Kennedy moved, Whiting seconded, allowing payment of claim #1323 to T & T Corp for \$320. Roll call vote: Yea: Fritch, Kennedy, Whiting. Nay – none.

- Administrator Clymer reported 1260 pounds of scrap wire had been sold at \$2.85 / pound to Anderson Wrecking Co.
