The purpose of the public hearing was to consider a request for a special use permit from Eagle Crest Academy to place a sign outside the R-2 zoning setback requirements at 1710 Avenue A. Zoning regulations require signs to be placed no more than five feet from the building. The proposal would place the 2'8" x 26' sign ten feet inside the property line between the properties of 1710 and 1720 Avenue A.

Strauser moved, Kennedy seconded, to approve the Special Use Permit for sign placement ten feet from the front property line as requested. Roll call vote: Yea – Oliver, Strauser, Whiting, Kennedy. Nay – none.

Kennedy moved, Oliver seconded, allowing payment of claims against the City, \$36,021.33; Public Works Division \$333,609.04, except #4848; and the December 6 payroll of \$34,785.67. Roll Call vote: Yea – Whiting, Strauser, Oliver, Kennedy. Nay – none.
