Mayor Hudson opened the meeting and public hearing at 5:30 p.m. Advance notice and a copy of the agenda were given to the Council and members of the press. City Council meetings are conducted in accordance with the Open Meetings Act, a copy of which is available for public inspection on the north wall of the Council Chambers.

Gary Steele with Miller & Associates discussed replacements to add to the existing map on the 1 & 6 Year Road Program. The inlets and pipe at 16th and J are undersized and there is no storm sewer on 20th Street. Administrator Clymer said that an idea would be to look at putting in storm sewer in the future, the issue was there before the hospital addition, but has gotten bigger. All other big buildings such as the school have storm sewer for runoff.

Community Comments:

There were 58 letters sent out to the last homeowners of Phase I on the Sidewalk Repair Program. There have been 30 fixed and approved, 15 signed an agreement to get them taken care of and 13 haven't made any contact with the City. There were 72 letters sent out on the new Phase II Sidewalk Repairs and 2 have already fixed them.

- Council said the sidewalks are looking nice!
- The tree board met last week and they did apply for Retree Nebraska. They received 10 trees and they are planted at the 4-plex, sewer treatment plant, and the viaduct area.

Attorney Bacon said he could be cited for a violation of an ordinance and he will look further into this.
