Dana Daniels with Miller and Associates discussed repainting the interior and exterior of the water tower tank. They will stick with a staggered orange pattern for the flight zone. They will power wash the outside and sand it to get the clear coat off. The riser has lots of rust which is not abnormal and they will do a complete blast. They will clear blast 3 coats of zinc and 2 coats of epoxy similar to the original. It will take a minimum of 2 months to finish the painting. The majority of the time will be used to take the coating off the inside. They usually get 3-4 bids.

Kennedy moved, Janssen seconded, to approve authorization to go out for bids. Roll call vote: Yea - Richeson, Waskowiak, Janssen, Kennedy. No - None.

CJ Poltack with West Central Nebraska Development District discussed that they help with nuisance abatement, community development projects, and have a mapping specialist on staff.
