DISCUSSION ITEMS:

Dr. Anna Dalrymple asked for consideration of a Mask Mandate in the current times with COVID-19 19. The following people spoke in favor of instituting a Mask Mandate: Dr. Carol Shackleton, Aravind Nienon. The following people spoke against a Mask Mandate: Kristen Rickertsen, Rev. Jeff Cottingham, Linda Butterfield, Clint Demoret, Austin Fletcher, Diane Kinnan, Keith Williamson.

After hearing all the public input for and against the Mask Mandate Kennedy states that a Resolution would be a more appropriate way to accomplish the task at hand. This resolution will encourage the citizens to wear masks but not require them. Kennedy asked Chief Olson to discuss what officers will be responding to. Chief Olson stated that officers will only be responding to non-emergency calls by phone as much as possible but will continue to respond to all emergency calls. After no further discussion Kennedy moved, Janssen seconded to motion to move forward with Resolution at a special meeting Thursday December 17, 2020 at 8:30 a.m.

Administrator Greer discussed Resolution 2020-22 REDLG Application #5 Hospital Upgrade #4 Medication Dispenser. The issue at hand requires the Council to accept USDA rules through a resolution in order receive the grant. After no further discussion Richeson moved, Kennedy seconded to approve Resolution 2020-22 REDLG Application #5 Hospital Upgrade #4 Medication Dispenser. Roll call vote: Yea –Janssen, Kennedy, Buddenberg, Richeson. No – none.

Tobin Buchanan-City Fiscal Agent introduced Ordinance 997 to authorize issuance of up to \$1,725,000 in Sewer Revenue Bonds to refinance outstanding loans from the Nebraska Department of Environment and Energy. Buchanan explained that this will take the NDEQ loans C317395, C317568, and C317781 and refinance them for a savings of approximately \$72,000.00. Janssen moved, Richeson seconded that the statutory rule requiring reading on three different days be suspended. Roll call vote: Yea –Janssen, Kennedy, Buddenberg, Richeson. No – none.

The motion to suspend the rules was adopted by a three-fourths vote of the Council and the statutory rule was declared suspended for the consideration of said ordinance.

Ordinance 997 was then read by title

ORDINANCE NO. 997

AN ORDINANCE AUTHORIZING THE ISSUANCE OF SEWER REVENUE REFUNDING BONDS, SERIES 2021, OF THE CITY OF GOTHENBURG, NEBRASKA, IN THE AGGREGATE PRINCIPAL AMOUNT OF NOT TO EXCEED \$1,725,000 FOR THE PURPOSE OF PROVIDING FOR PERMANENT FINANCING AND REFINANCING OF THE COSTS OF ENLARGING, EXPANDING AND IMPROVING THE CITY'S SANITARY SEWER SYSTEM BY PAYING AND REDEEMING THE CITY'S CURRENTLY OUTSTANDING SEWER REVENUE NOTES TO THE NEBRASKA DEPARTMENT OF ENVIRONMENT AND ENERGY; DIRECTING THE APPLICATION OF THE PROCEEDS OF SAID BONDS; PRESCRIBING THE FORM, TERMS AND DETAILS OF SAID BONDS; PLEDGING AND HYPOTHECATING THE REVENUES AND EARNINGS OF THE SEWER SYSTEM OF SAID CITY FOR THE PAYMENT OF SAID BONDS AND INTEREST THEREON; PROVIDING FOR THE COLLECTION, SEGREGATION AND APPLICATION OF THE REVENUES OF SAID SEWER SYSTEM; ENTERING INTO A CONTRACT ON BEHALF OF THE CITY WITH THE HOLDERS OF SAID BONDS; AND PROVIDING FOR PUBLICATION OF THIS ORDINANCE IN PAMPHLET FORM.

After reading Janssen moved, Kennedy seconded final passage Ordinance 997.

Mayor Hudson then asked, *Shall Ordinance 997 be passed and adopted?*" Roll call vote: Yea – Janssen, Kennedy, Buddenberg, Richeson. No – none.

The passage and adoption of said ordinance having been concurred in by a majority of all members of the Council, the Mayor declared the ordinance adopted and the Mayor, in the presence of the Council, signed and approved the ordinance and the City Clerk attested the passage and approval of the same and affixed her signature thereto and ordered the ordinance to published in pamphlet form as provided therein.

Buddenberg moved, Janssen seconded, to adjourn the meeting at 6:35 p.m. Roll call vote: Yea – Janssen, Kennedy, Buddenberg, Richeson. No – none.
