

ORDINANCE NUMBER 145

An Ordinance to vacate the unvacated portion of the intersection of 9th Street, 12th Street and the Original Avenue A in the City of Gothenburg, Dawson County, Nebraska, and to repeal all ordinances in conflict herewith.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GOTHENBURG, NEBRASKA:

Section 1. Whereas that portion of the intersection of 9th Street, 12th Street and Avenue A as originally platted in the City of Gothenburg, Nebraska, is too large to economically maintain, and whereas it is an irregular shape and is seldom used, it is deemed expedient to vacate said intersection.

Section 2. That portion of the intersection of 9th Street, 12th Street and Avenue A as originally platted, which is not now vacated, and which is more particularly described as commencing at the Northwest corner of Section Fifteen (15), Township Eleven (11) North, Range Twenty-five (25), West of the 6th P. M., in Dawson County, Nebraska, thence South along the West boundary of said Section Fifteen to a point where the same intersects the West boundary line of Lot Six (6), of Block Twelve (12), of the First Addition of the City of Gothenburg, Nebraska, thence Northeasterly along the West boundary of said Lot Six (6) and continuing along the West boundary of Lot Seven (7) of Block Thirteen (13) of the First Addition to the City of Gothenburg, Nebraska to a point of intersection with the North boundary of said Section Fifteen (15), thence West along the North boundary of said Section Fifteen (15) to the Northwest corner of said Section Fifteen (15), being the place of beginning, is hereby vacated.

Section 3. Land so vacated in Section 2 hereof shall revert to the owners of the lands or lots abutting thereto.


Section 4. All ordinances and parts of ordinances in conflict herewith shall be and the same are hereby repealed.
