

ORDINANCE 220

AN ORDINANCE TO AMEND ARTICLE 40 OF THE GOTHENBURG MUNICIPAL CODE RELATING TO WATER WORKS, TO REPEAL CERTAIN SECTIONS OF SAID ARTICLE AND TO AMEND CERTAIN SECTIONS OF SAID ARTICLE; PROVIDING FOR THE REPEAL OF PRIOR ORDINANCES IN CONFLICT; PROVIDING FOR THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND TAKE EFFECT.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GOTHENBURG, NEBRASKA:

Section 1. Section 12-40-4 of the Gothenburg Municipal Code is hereby repealed.

Section 2. Section 12-40-2 is hereby amended to read as follows:

Application for Water required. Every person desireing a supply of water must make application therefor to the Board upon blanks to be furnished by them for that purpose. The application must state truly and fully all the uses to which the water is to be applied, and no different or additional use will be allowed except by permission of said Board. Not more than one distinct premises, tenement or house shall be supplied from one tap, except by special permission.

Section 3. Section 12-40-3 is hereby amended to read as follows:  
Payments, When Due, Minimum Charge. Water rents will be due and payable monthly on the first day of each month. Water rents must be paid at the office of the City Clerk.

Section 4. Section 12-40-28 is hereby amended to read as follows:  
Water Meters Required. No water shall be furnished by the City of Gothenburg to commercial consumers except at meter rates to parties who shall purchase an approved meter through the Board. If in the judgement of the Board, any meter shall be out of repair or injured the cost of the replacement or repair shall be charged to the consumer and collected as water rent.

Section 5. Section 12-40-32 is hereby amended to read as follows:  
Meter Used in Parks. All hydrants, and other conduits which may hereafter be **used** on any public park, public school or other public building shall before using any water therefrom on said public parks, schools, or buildings be provided with some suitable water meter to be furnished by the City of Gothenburg and all water used thereon shall be measured and the public park fund, shcool or other fund shall be charged and pay to the municipal water fund the same rate for all water used as is

charged to any private commercial consumer for use of city water.

Repeal of Prior Ordinance in Conflict. All ordinances and parts of ordinances passed and approved prior to the passage and approval of this ordinance and in conflict therewith are hereby repealed.

When Operative. This ordinance shall be in full force and take effect from and after its passage, approval and publication according to law.
