

ORDINANCE NO. 224

An Ordinance to vacate Avenue C from the north boundary of Third Street to the South Boundary of Fourth Street; Avenue D, from the north boundary of Third Street to a point of intersection with the Tail Race; Third Street from a point being an extension of the Lot line between Lots One (1) and Two (2), in Block Twenty-three (23), Hiles and Reynolds Addition to the City of Gothenburg, Nebraska, east to the Tail Race; 10 feet on each side of Third Street, from an extension of the line dividing Lots One (1) and Two (2), of Block Twenty-three (23), Hiles and Reynolds Addition to the City of Gothenburg, Nebraska, west to the east line of Avenue B; 10 feet on each side of Fourth Street from the East line of Avenue B to the West line of Avenue D; a 10 foot strip on each side of Avenue B from the north side of Third Street to the south side of Fourth Street; all in the City of Gothenburg, Nebraska; providing that said land shall revert to the adjacent owners as provided by law, providing for the repeal of any Ordinance in conflict herewith providing when said Ordinance shall take effect.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA.

1. Whereas, Avenue C between Third Street and Fourth Street, Avenue D between Third Street to a point of intersection with the Tail Race, Third Street from the extension of the Lot line between Lots One (1) and Two (2), Block Twenty-three (23) of Hiles and Reynolds Addition east to the Tail race, a 10 foot strip on both sides of Third Street from the extension of the Lot line between Lots One (1) and Two (2) in Block Twenty-three (23), Hiles and Reynolds Addition to Avenue B, a 10 foot strip on both sides of Fourth Street from Avenue B to Avenue D, and a 10 foot strip on both sides of Avenue B from Third Street to Fourth Street are no longer necessary for the use of the City of Gothenburg, and it would be to the best interests of said City if the said streets were vacated.

2. Avenue C from the north boundary of Third Street to the south boundary of Fourth Street is hereby vacated.

3. Avenue D from the north boundary of Third Street to the intersection of the Tail Race is hereby vacated.

4. Third Street from the extension of the line between Lots One (1) and Two (2) in Block Twenty-three (23) of Hiles and Reynolds Addition to the City of Gothenburg, Nebraska, east of the Tail Race is hereby vacated.

5. 10 Foot strip on each side of Third Street between an extension of the lot line between Lots One (1) and Two (2), Block Twenty-three (23), Hiles and Reynolds Addition to the City of Gothenburg, Nebraska, West to Avenue B is hereby vacated.

6. That a 10 foot strip on each side of Fourth Street from the East line of Avenue B to the West line of Avenue D, is hereby vacated.

7. That the land so vacated in Section 2, Section 3, Section 4, Section 5 and Section 6, hereof shall revert to the owners of the lands or lots abutting thereto.

8. All ordinances or parts of ordinances in conflict herewith shall be and the same are hereby repealed.

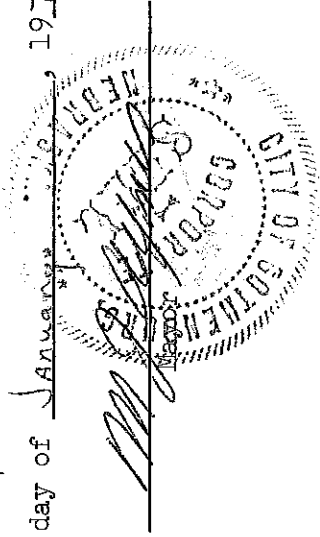
This Ordinance shall be in force and effect from and after its passage, approval and publication as required by law.
