

ORDINANCE NUMBER 267

AN ORDINANCE AMENDING SECTION FOUR OF ORDINANCE 99 AS HAS BEEN HERETOFORE AMENDED AND PROVIDING FOR AN INCREASE IN THE MAXIMUM RATES TO BE CHARGED BY THE NEBRASKA NATURAL GAS COMPANY FOR GAS SOLD UNDER ITS EXISTING FRANCHISE.

BE IT ORDAINED BY THE City Council AND Mayor OF THE CITY OF Gothenburg, Dawson COUNTY, NEBRASKA:

SECTION 1. That the Nebraska Natural Gas Company, its successors and assigns, shall charge for gas sold under its existing franchise at rates not higher than the following:

MONTHLY RATE SCHEDULE

First	500 Cu.Ft.	27.5%	per 100 cu. ft.
Next	1,500 Cu.ft.	23.5%	per 100 cu. ft.
Next	2,000 Cu.ft.	12.0%	per 100 cu. ft.
Next	3,000 cu.ft.	11.1%	per 100 cu. ft.
Next	43,000 cu.ft.	10.5%	per 100 cu. ft.
Next	50,000 cu. ft.	10.0%	per 100 cu. ft.
Over	100,000 cu. ft.	9.0%	per 100 cu. ft.

Minimum Rate -- \$1.00 per month

Gross Rate (above plus 5% not to exceed \$2.00) applied if bill not paid within 10 days after date of bill.

SECTION 2. The Schedule or Rates in Section 4 of Ordinance 99 as has been heretofore amended is hereby amended accordingly. All other portions of said Ordinance 99 not in conflict herewith shall be unaffected by this amendment and remain in full force and effect.

SECTION 4. That within thirty (30) day after the passage and approval of this Ordinance, said Company shall prepare and file an unconditional written acceptance of said Schedule of rates.

SECTION 5. This Ordinance shall be in full force and effect from and after it passage and approval.
