

ORDINANCE NO. 282

An ordinance to vacate the platted street North (N) and parallel to Block Sixty (60), Bergstrom's Addition to the City of Gothenburg, Dawson County, Nebraska, between Avenue I and Avenue J, and more particularly described as

Beginning at a point Forty Feet (40') Northeast (NE) of the Northwest Corner (NW) of Block Sixty (60), Bergstrom's Addition to the City of Gothenburg, Dawson County, Nebraska; thence Southwest (SW) along the East (E) line of Avenue I a distance of Forty Feet (40'); thence Southeast (SE) along the North (N) line of Block Sixty (60) of said Bergstrom's Addition to the City of Gothenburg, Dawson County, Nebraska, to the Northeast (NE) Corner of said Block Sixty (60); thence Northeast (NE) along the West (W) line of Avenue J, a distance of Forty Feet (40'); thence Northwest (NW) along a line which is Forty Feet (40') North (N) of and parallel to the North (N) line of said Bergstrom's Addition, to the place of beginning.

and to repeal all ordinances in conflict herewith.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF GOTHENEUBURG,

NEBRASKA:

Section 1.

WHEREAS, the platted street North (N) and parallel to Block Sixty (60), Bergstrom's Addition to the City of Gothenburg, Between Avenue I and Avenue J, and more particularly described as

Beginning at a point Forty Feet (40') Northeast (NE) of the Northwest Corner (NW) of Block Sixty (60), Bergstrom's Addition to the City of Gothenburg, Dawson County, Nebraska; thence Southwest (SW) along the East (E) line of Avenue I a distance of Forty Feet (40'); thence Southeast (SE) along the North line (N) of Block Sixty (60) of said Bergstrom's Addition to the City of Gothenburg, Dawson County, Nebraska to the Northeast (NE) Corner of said Block Sixty (60); thence Northeast (NE) along the West (W) line of Avenue J, a distance of Forty Feet (40'); thence Northwest (NW) along a line which is Forty Feet (40') North (N) of and parallel to the North (N) line of said Bergstrom's Addition, to the place of beginning.

has never been an open street and it is not feasible to open said street, nor would it be economical to maintain said street, wherefore, that portion of the platted street North (N) and parallel to Block Sixty (60), Bergstrom's Addition to the City of Gothenburg, Dawson County, Nebraska, between Avenue I and Avenue J, and more particularly described as

Beginning at a point Forty Feet (40') Northeast (NE) of the Northwest (NW) Corner of Block Sixty (60), Bergstrom's Addition, to the City of Gothenburg, Dawson County, Nebraska; thence Southwest (SW) along the East (E) line of Avenue I a distance of Forty Feet (40'); thence Southeast (SE) along the North (N) line of Block Sixty (60) of said Bergstrom's Addition to the

City of Gothenburg, Dawson County, Nebraska to the Northeast (NE) Corner of said Block Sixty (60); thence Northeast (NE) along the West (W) line of Avenue J, a distance of Forty Feet (40'); thence Northwest (NW) along a line which is Forty Feet (40') North (N) of and parallel to the North (N) line of said Block Sixty (60) of Bergstrom's Addition, to the place of beginning.

is hereby vacated.

Section 2.

The land so vacated in Section 1 hereof shall revert to the owners of the lands ~~now~~ lots abutting thereto.

Section 3.

All ordinances and parts of ordinances in conflict herewith shall be and the same are hereby repealed.

Section 4.

This ordinance shall be in force and effect from and after its passage, approval and publication as required by law.
