

ORDINANCE NO. 299

An ordinance to vacate the alley running East (E) and West (W) in Block Forty-Six (46), First Addition to the City of Gothenburg, Dawson County, Nebraska, providing that said land shall revert to the adjacent owners as provided by law; providing for repeal of any ordinances in conflict herewith; and providing when said ordinance shall take effect.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA:

SECTION I. WHEREAS, that the alley running East (E) and West (W) in Block Forty-Six (46), First Addition to the City of Gothenburg, Dawson County, Nebraska, and more particularly described as beginning at the Northeast (NE) corner of Lot Twelve (12), Block Forty-Six (46), First Addition to the City of Gothenburg, Dawson County, Nebraska; thence West (W) along the North (N) line of Lots Twelve (12), Eleven (11), Ten (10), Nine (9), Eight (8), and Seven (7), a distance of Three Hundred Feet (300') to the Northwest (NW) corner of Lot Seven (7) in said Block; thence North (N) Twenty Feet (20') to the Southwest (SW) corner of Lot Six (6), in said Block; thence East (E) Three Hundred Feet (300') along the South (S) line of Lots Six (6), Five (5), Four (4), Three (3), Two (2), and One (1), to the Southeast (SE) corner of Lot One (1) in said Block, thence South (S) Twenty Feet (20') to the place of beginning, is no longer necessary for the use of the citizens of Gothenburg, and it would be to the best interest of said City if the said alley were vacated.

SECTION II. That portion of the alley running East (E) and West (W) in Block Forty-Six (46), First Addition to the City of Gothenburg, Dawson County, Nebraska, and more particularly described as beginning at the Northeast (NE) corner of Lot Twelve (12), Block Forty-Six (46), First Addition to the City of

Gothenburg, Dawson County, Nebraska; thence West (W) along the North (N) line of Lots Twelve (12), Eleven (11), Ten (10), Nine (9), Eight (8), and Seven (7), a distance of Three Hundred Feet (300') to the Northwest (NW) corner of Lot Seven (7) in said Block; thence North (N) Twenty Feet (20') to the Southwest (SW) corner of Lot Six (6), in said Block; thence East (E) Three Hundred Feet (300') along the South (S) line of Lots Six (6), Five (5), Four (4), Three (3), Two (2), and One (1), to the Southeast (SE) corner of Lot One (1) in said Block, thence South (S) Twenty Feet (20') to the place of beginning, is hereby vacated.

SECTION III. That the land so vacated in Section II, above, shall revert to the owners of lands or lots abutting thereto.

SECTION IV. All ordinances and parts of ordinances in conflict herewith shall be and the same are hereby repealed.

SECTION V. This ordinance shall be in force and effect from and after its passage, approval and publication as required by law.
