

ORDINANCE NO. 354

An Ordinance amending Article 10-117, Gothenburg Municipal Code of 1974, as amended; restricting the sale of beer and alcoholic liquors within the municipality; providing for the hours thereof; providing for the repeal of all ordinances in conflict herewith; and providing for an effective date.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA.

SECTION I. Article 10-117 of the Gothenburg Municipal Code of 1974, as amended, is hereby amended to read as follows, to-wit:

Article 10-117. Alcoholic Beverages; Hours of Sale.
It shall be unlawful for any person or persons to sell or dispense any alcoholic liquor during the hours the polls are open on the day in which any statewide primary or general election is conducted. It shall further be unlawful for any licensed person or persons or their agents to sell any alcoholic liquors within the Municipality on Sundays, except as provided herein. It shall be lawful to sell beer on and off sale between the hours of six (6:00) o'clock A.M., and eleven forty-five (11:45) o'clock P.M. on the secular days; Provided, on Saturdays such sales shall be allowed until one (1:00) o'clock A.M. Sunday. It shall be lawful to sell liquor off sale between the hours of six (6:00) o'clock A.M., and eleven forty-five (11:45) o'clock P.M. on the secular days; Provided, on Saturdays such sales shall be allowed until one (1:00) o'clock A.M. Sundays. No alcoholic liquors, including beer, shall be sold at retail or dispensed on the first (1st) day of the week, commonly called Sunday, between the hours of one (1:00) o'clock A.M. Sunday and six (6:00) o'clock A.M. Sunday. Between the hours of six (6:00) o'clock A.M. Sunday and eleven forty-five (11:45) o'clock P.M. Sunday, beer and wine may be sold for consumption off the premises, sales in original package only. It shall be lawful to sell or dispense alcoholic liquors under a bottle club license between the hours of six (6:00) o'clock A.M. and eleven forty-five (11:45) o'clock P.M. on the secular days; Provided, on Saturdays such sales shall be allowed until one (1:00) o'clock A.M. Sunday.

No person or persons shall consume any alcoholic beverages on licensed premises for a period of time longer than fifteen (15) minutes after the time fixed herein for stopping the sale of alcoholic beverages on the said premises.

SECTION II. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION III. This ordinance shall be in full force and effect from and after its passage, approval and publication as


provided by law.
