

ORDINANCE NO. 524

AN ORDINANCE AMENDING ORDINANCE 525, AND SECTION  
3-108 OF THE GOTHENBURG MUNICIPAL CODE, ORDINANCE NO. 272,  
AS AMENDED; PROVIDING FOR AN INCREASE IN TAP FEE RATES;  
PROVIDING FOR AN EFFECTIVE DATE AND REPEALING ALL ORDINANCES  
OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF  
THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

Section 1. A copy of Ordinance No. 525 is attached hereto and incorporated herein by this reference.

Section 2. Section 3-108 of the Gothenburg Municipal Code is hereby amended to read as follows:

Municipal Water Department; Minimum Rates. All water consumers shall be liable for the minimum rate provided by ordinance unless and until the consumer shall, by written order, direct the Utilities Foreman to shut off the water at the stop box, in which case he shall not be liable thereafter for water rental until the water is turned on again. Below are the effective water use rates and tap fees to be charged consumers of the Municipal water supply; which shall be paid to the Cashier of the Municipality in accordance with the following schedule:

TAP FEES

Tap fees for tapping into the City Water System shall be provided at the City's actual cost for labor, material and overhead.

Section 4. This Ordinance repeals all ordinances or parts of ordinances in conflict herewith.
