ORDINANCE NO. 540

AN ORDINANCE AMENDING SECTION 5-304 OF THE MUNICIPAL CODE OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA, ORDINANCE NO. 272 AS AMENDED; REVISING SPEED LIMITS WITHIN THE CITY OF GOTHENBURG, AMENDING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith AND PROVIDING AN EFFECTIVE DATE.

Section 1. A copy of Section 5-304 of the Gothenburg Municipal Code, Ordinance No. 272 as amended, is attached hereto and incorporated herein by this reference as though fully set forth.

Section 2. Section 5-304 of Ordinance No. 272 as amended, is hereby amended to read as follows:

Section 5-304 SPEED LIMITS. No person shall operate a motor vehicle on any street, alley or other place at a rate of speed greater than is reasonable and prudent under the conditions, but in no event shall the speed of a vehicle exceed the following:

U.S. Highway #30 from the west corporate limits to the west end of the bridge over the tail race..... 40 miles per hour

U.S. Highway #30 from the west end of the bridge over the tail race to a point 200 feet east of the east line of Avenue I
..... 35 miles per hour

U.S. Highway #30 from a point 200 feet east of the east line of Avenue I to the east corporate limits..... 45 miles per hour

State Highway N-47 from a point on the south corporate limits to the north end of the bridge over the north channel of the Platte River 50 miles per hour

State Highway N-47 from the north end of the
bridge over the north channel of the Platte
River to 9th Street 35 miles per hour

State Highway N-47 from 9th Street to 11th
Street on Avenue G and from Avenue G to Lake
Avenue on 11th Street.... 25 miles per hour

Nebraska Link (L-24D) from U.S. Highway #30
to 11th Street on Avenue D and from Avenue D
to Lake Avenue on 11th Street
..... 25 miles per hour

Lake Avenue from State Highway N-47 (at its
intersection with 4th Street) to the south
line of U.S. Highway #30
..... 25 miles per hour

Lake Avenue from the South line of U. S.
Highway #30 to the North line of 11th Street
..... 25 miles per hour
State Highway N-47 from the North line of
11th Street to the North line of 20th Street
..... 30 miles per hour

State Highway N-47 from the North line of
20th Street to the North corporate limits
..... 35 miles per hour

School zones as designated by the Governing
Body..... 15 miles per hour

All roads within the boundaries of the
Municipal Parks..... 10 miles per hour

Avenue L from the North line of 12th Street
to Highway 30
..... 35 miles per hour

Avenue M from the North line of 12th Street
to the South line of 27th Street
..... 35 miles per hour

All streets within the business district
..... 20 miles per hour

All other streets and highways within the
corporate limits..... 25 miles per hour

Where a different maximum speed is set by
ordinance, appropriate signs shall be posted.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall become effective from and after its passage, approval and publication, according to law.
