

ORDINANCE NO. 587

AN ORDINANCE APPROPRIATING MONEY FOR THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA FOR THE PURPOSE OF PAYING EXPENSES, LIABILITIES, AND IMPROVEMENTS, BOND MATURITIES AND INTEREST FOR THE FISCAL YEAR AUGUST 1, 1992 TO JULY 31, 1993, REPEALING ALL ORDINANCES IN CONFLICT HEREWITH, DECLARING AN EMERGENCY AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

Section 1. This ordinance shall be known as the Amended Annual Appropriation Bill for the City of Gothenburg, Dawson County, Nebraska.

Section 2. There is hereby appropriated for the purpose of paying the expenses, liabilities, necessary improvements, bond maturities, and interest of the City of Gothenburg, Dawson County, Nebraska, for the fiscal year August 1, 1992 to July 31, 1993, the sum of \$9,349,393.00 which includes Public Works Appropriations and funds on hand, for the following funds:

General Fund	Police Fund
Street Fund	City Hall Fund
Park Fund	Fire Fund

Section 3. The total amount of property tax requirements shall be \$566,165.00. The difference between the total amount appropriated and the property tax requirement shall be paid from other receipts and money on hand and there shall be no tax levied

for this sum.

Section 4. The unexpended balance in all funds at the close of the fiscal year ending on the last day of July, 1992 are hereby reappropriated to the respective funds for the coming year.

Section 5. There is an emergency in that it will be necessary to expend funds of the City before this Ordinance can be read at three different meetings, passed, and published according to law, and three-fourths or more of the members of the City Council have voted for the passage of this Ordinance.

Section 6. This Ordinance shall take effect immediately, be posted in three public places within the City of Gothenburg, Nebraska, and be published according to law.

Section 7. All ordinances or parts of ordinances in conflict herewith are hereby repealed.
