

ORDINANCE NO. 616

AN ORDINANCE TO VACATE A PORTION THE ALLEY IN BLOCK 31 OF SUMMIT ADDITION TO THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA; RESERVING AN EASEMENT FOR UTILITIES THEREIN; PROVIDING FOR THE REVERSION OF THE OWNERSHIP THEREOF; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH AND PROVIDING AN EFFECTIVE DATE:

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

Section 1. The City Council of the City of Gothenburg, Dawson County, Nebraska hereby deems it in the public interest to vacate a portion of the alley in Block 31, Summit Addition as particularly described hereafter.

Section 2. Subject to the terms of Section 3 hereof, all that portion of the alley running east and west in Block 31, Summit Addition from the east line of said Block to a point 10' west of the west lines of Lots 6 and 19 in said Block 31 is hereby vacated.

Section 3. The City hereby reserves an Easement in that portion of the alley so vacated for utility purposes including placement, replacement, repair and maintenance of electrical, overhead and underground lines and conduit together with sewer, water, and telecommunication lines and such other services as the City may desire to locate to locate, place, relocate, and maintain in such easement.

Section 4. The ownership of the alley so vacated shall revert to the adjoining land owners, pursuant to law.

Section 5. That portion of the alley in Block 31, Summit Addition, not so vacated shall remain titled in the City of Gothenburg and shall be retained for public purposes.


Section 6. All ordinances and parts of ordinances in conflict herewith are hereby repealed.
