

ORDINANCE NO. 633

AN ORDINANCE ANNEXING REAL ESTATE IN THE NORTH EAST QUARTER AND IN THE SOUTH EAST QUARTER OF SECTION 15, TOWNSHIP 11 NORTH, RANGE 25, WEST OF THE 6TH P.M., DAWSON COUNTY, NEBRASKA, DESCRIBING THE BOUNDARIES THEREOF; INCLUDING THE SAME WITHIN THE CORPORATE LIMITS OF THE CITY OF GOTHENBURG; DECLARING THAT SUCH LANDS ARE URBAN OR SUBURBAN IN CHARACTER; ESTABLISHING AN I-2 ZONING CLASSIFICATION THEREON; REPEALING ALL ORDINANCES AND CONFLICT HERewith AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

Section 1. The real estate described in this section is hereby annexed to and included within the corporate limits of the City of Gothenburg, Dawson County, Nebraska to-wit:

All of that part of the North East Quarter of Section 15, Township 11 North, Range 25 West of the 6th P.M., lying South of the South line of U.S. Highway 30, and

All of that part of the South East Quarter of Section 15, Township 11 North, Range 25 West of the 6th P.M., lying South of the North line of the Union Pacific Railway right of way, EXCEPT the South 990 feet of said South East Quarter, all in Dawson County, Nebraska.

Section 2. The real estate described in Section 1 hereof is declared to be contiguous and adjacent to the corporate limits of the City of Gothenburg, Dawson County, Nebraska.

Section 3. The real estate described in Section 1 is hereby declared to be urban and suburban in character and proper for inclusion within the corporate limits of the City of Gothenburg.

Section 4. The real estate described in Section 1 hereof is hereby classified as I-2 for purposes of the Gothenburg Zoning Ordinance.

Section 5. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 6. This ordinance shall become effective from and after its passage, approval and publication according to law.
