

ORDINANCE NO. 651

AN ORDINANCE VACATING A PORTION AVENUE I, A PORTION OF AVENUE J, A PORTION OF AVENUE H, A PORTION OF 5TH STREET, AND ALL THE ALLEYS IN BLOCK 1, BLOCK 2, AND BLOCK 3, ALL ARE LOCATED WITHIN MANN'S SUBDIVISION TO THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA; PROVIDING FOR THE REVERSION OF THE OWNERSHIP THEREOF; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith AND PROVIDING AN EFFECTIVE DATE:

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

Section 1. All that portion of the Avenue J located south of the south line of 6th Street in the City of Gothenburg, Dawson County, Nebraska is hereby vacated.

Section 2. All that portion of the Avenue I located south of the south line of 6th Street in the City of Gothenburg, Dawson County, Nebraska is hereby vacated.

Section 3. All that portion of the Avenue H located south of the north line of Mann's Subdivision to the City of Gothenburg, Dawson County, Nebraska is hereby vacated.

Section 4. All that portion of 5th Street located in Mann's Subdivision to the City of Gothenburg, Dawson County, Nebraska is hereby vacated. The portion of said street is vacated is only that portion which was previous dedicated on the Plat of Mann's Subdivision to the City of Gothenburg, Dawson County, Nebraska.

Section 5. The alleys in Block 1, Block 2, and Block 3 in Mann's Subdivision to City of Gothenburg, Dawson County, Nebraska are hereby vacated.


Section 6. All public streets and alleys vacated by the terms and provisions of this ordinances shall revert to the property owners joining said vacated streets and alleys.

Section 7. All ordinances and parts of ordinances in conflict herewith are hereby repealed.


Section 8. This ordinance shall become effective from and after its passage, approval and publication according to law.
