

ORDINANCE NO. 2664

AN ORDINANCE CONVEYING PERSONAL PROPERTY TO THE HIGH BIDDERS AT PUBLIC AUCTION; NAMING THE SUCCESSFUL BIDDERS; IDENTIFY THE PERSONAL PROPERTY SOLD; AND PROVIDING FOR THE METHOD OF PAYMENT, REPEALING ALL ORDINANCES PARTS OF ORDINANCES IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

Section 1. The City, pursuant to the Resolution #1996-28 provided for the public notice of sale of personal property described hereafter, subject to the public's right of remonstrance. Said remonstrance has passed without the filing of the same, and a public auction was held on the 14th day of December, 1996 at City Hall.

Section 5. All ordinances or parts of ordinances in conflict herewith are hereby repealed.


Section 6. This ordinance shall become effective from and after its passage, approval and publication as required by law.
