

ORDINANCE 721

AN ORDINANCE AMENDING CHAPTER 10, ARTICLE 1, SECTION 117 OF THE GOTHENBURG MUNICIPAL CODE, ORDINANCE 272, PROVIDING FOR HOURS OF SALE OF ALCOHOLIC BEVERAGES TO INCLUDE BEER AND WINE INSIDE THE CORPORATE LIMITS OF GOTHENBURG FOR CONSUMPTION ON THE PREMISES OF RESTAURANTS ONLY; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA, AS FOLLOWS:

Section 1. A copy of Section 117, Article 1, Chapter 10 of the Gothenburg Municipal Code, as amended by ordinance 572, is attached hereto and incorporated herein by this reference as though fully set forth.

Section 2. Section 117, Article 1, Chapter 10 of the Gothenburg Municipal Code, as amended by ordinance 572, is hereby amended to read as follows:

It shall be unlawful for any licensed person or their agents to sell any alcoholic liquors within the municipality except as provided herein, and except as may be otherwise provided by the laws of the State of Nebraska, to-wit:

LIQUOR AND BEER OFF SALE

Sunday	12:00 noon to 6:00 P.M.
Monday through Friday	6:00 A.M. to 11:45 P.M.
Saturday	6:00 A.M. to 1:00 A.M. Sunday

BEER ON SALE

Monday through Friday	6:00 A.M. to 11:45 P.M.
Saturday	6:00 A.M. to 1:00 A.M. Sunday
Sunday	<u>4 pm - 10 pm</u>

BOTTLE CLUB

Monday through Thursday	6:00 A.M. to 11:45 P.M.
Friday	6:00 A.M. to 1:00 A.M. Saturday
Saturday	6:00 A.M. to 1:00 A.M. Sunday
Sunday	<u>4 pm - 10 pm</u>

Provided, however, on the 31st day of December in each year, it shall be lawful to dispense alcoholic liquors, including beer and wine, under a bottle club license and on and off sale and on the premises of restaurants between the hours of 6:00 P.M. and 1:00 A.M., on the following January 1, not withstanding the above limitations.

No person shall consume any alcoholic beverage on a licensed premise for a period of time longer than 15 minutes after the time fixed herein for stopping the sale of alcoholic beverages on said premises.

Section 3. All ordinances and part of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall take effect from and after its passage, approval and publication according to law.

§10-117 ALCOHOLIC BEVERAGES; HOURS OF SALE.

(1) It shall be unlawful for any licensed person or their agents to sell any alcoholic liquors within the Municipality except as provided herein, and except as may be otherwise provided by the laws of the State of Nebraska, to wit:

LIQUOR AND BEER OFF SALE

Sunday ..... 12:00 noon to 6:00 p.m.

Monday through Friday ..... 6:00 a.m. to 11:45 p.m.

Saturday ..... 6:00 a.m. to 1:00 a.m., Sunday

BEER ON SALE

Monday through Friday ..... 6:00 a.m. to 11:45 p.m.

Saturday ..... 6:00 a.m. to 1:00 a.m., Sunday

BOTTLE CLUB

Monday through Thursday ... 6:00 a.m. to 11:45 p.m.

Friday ..... 6:00 a.m. to 1:00 a.m., Saturday

Saturday ..... 6:00 a.m. to 1:00 a.m., Sunday

Provided, however, on the 31st day of December in each year, it shall be lawful to dispense alcoholic liquors, including beer, under a bottle club license and on and off sale license between the hours of 6:00 p.m. and 1:00 a.m., on the following January 1, not withstanding the above limitations.

(2) No person shall consume any alcoholic beverages on a licensed premise for a period of time longer than 15 minutes after the time fixed herein for stopping the sale of alcoholic beverages on said premises. (Ref. 53-179 RS Neb.)
