

ORDINANCE NO. 751

AN ORDINANCE AMENDING ORDINANCE NO 636, KNOWN AS THE MUNICIPAL CODE OF THE CITY OF GOTHENBURG, NEBRASKA, AMENDING SECTION 5-303 OF CHAPTER 5, ARTICLE 3, SETTING MAXIMUM SPEED LIMITS WITHIN THE MUNICIPAL BOUNDARIES OF THE CITY OF GOTHENBURG; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

Section 1. A copy of section 5-303 of Chapter 5, Article 3 of the Gothenburg Municipal Code, Ordinance No. 636 is attached hereto and incorporated herein by this reference.

Section 2. Section 5-303 of Chapter 5, Article 3 of the Gothenburg Municipal Code, Ordinance No. 636 is hereby amended to read as follows:

§5-303 SPEED LIMITS. No person shall operate a motor vehicle on any street, alley, or other place at a rate of speed greater than is reasonable and prudent under the conditions, but in no event shall the speed of a vehicle exceed the following:

U.S. Highway #30 from the west corporate limits to the west end of the bridge over the tail race.....	40 miles per hour
U.S. Highway #30 from the west end of the bridge over the tail race to a point 200 feet east of the east line of Avenue I.....	35 miles per hour
Highway #30 from a point 200 feet east of the east line of Avenue I to the east corporate limits.....	45 miles per hour
State Highway #47 from a point on the south corporate limits to a point 250 feet south of the South line of 4 th Street.....	50 miles per hour
State Highway #47 (Lake Avenue) from a point 250 feet south of the south line of 4 th Street to the south line of U.S. Highway #30.....	35 miles per hour

State Highway #47 (Lake Avenue) from the south line of U.S. Highway #30 to the north line of 13 th Street.....	25 miles per hour
State Highway #47 (Lake Avenue) from the north line of 13 th Street to the north line of 20 th Street.....	30 miles per hour
State Highway #47 (Lake Avenue) from the north line of 20 th Street to the north corporate limits.....	35 miles per hour
School zones as designated by the Governing Body.....	15 miles per hour
16 th Street from the west line of Avenue A to the west terminus of 16 th Street.....	15 miles per hour
All roads within the boundaries of the Municipal parks.....	10 miles per hour
4 th Street from the west line of 1 st Avenue to the west corporate limits of the City of Gothenburg.....	35 miles per hour
4 th Street from the east line of State Highway 47 to the west line of Cottonwood Drive	<u>35</u> miles per hour
27 th Street from the east line of Avenue G to the west line of Avenue M.....	35 miles per hour
All other streets and highways within the corporate limits.....	25 miles per hour

Where a different maximum speed is set by ordinance, appropriate signs shall be posted.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. This ordinance shall become effective from and after its passage, approval and publication as required by law.
