

ORDINANCE NO. 780

AN ORDINANCE AMENDING ORDINANCE NO. 490 & NO. 627, CHANGING A PORTION OF THE I (INDUSTRIAL) ZONE IN THE CITY LIMITS OF THE CITY OF GOTHENBURG, NEBRASKA TO AG-1 ZONE; DIRECTING A CHANGE OF THE ZONING MAP TO REFLECT SUCH AMENDMENT, REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, NEBRASKA, AS FOLLOWS:

Section 1. The real estate described on Exhibit "A" attached hereto in the City of Gothenburg, Nebraska, is hereby changed from zone I to zone AG-1 for purposes of the zoning ordinance of the City of Gothenburg.

Section 2. The Mayor and City Clerk are hereby directed to change the local zoning map in accordance with the rules and regulations of Ordinance No. 490 and Ordinance No. 627.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall become effective from and after its passage, approval and publication as required by law.



Thence continue North, and along the West Line of the Southeast Quarter of said Section 15, a distance of 15.00 feet;

Thence East, a distance of 246.00 feet;

Thence South, a distance of 143.50 feet;

Thence S 52°29'52" W, and along the North Line of Cozad Irrigation Canal, a distance of 278.21 feet;

Thence N 00°19'44" E, a distance of 297.88 feet;

Thence West, a distance of 27.00 feet, to the place of beginning, and containing 1.16 acres, more or less.

Thence continue North, and along the West Line of the Southeast Quarter of said Section 15, a distance of 298.30 feet;

Thence East, a distance of 246.00 feet;


Thence South, a distance of +27.50 feet;
