ORDINANCE NO. 781

AN ORDINANCE TO VACATE THE SOUTH 9.5 FEET OF 15TH STREET, BETWEEN THE EAST LINE OF AVENUE F AND THE WEST LINE OF AVENUE G, AND ABUTTING LOTS ONE AND TWELVE, BLOCK 13 OF EHMEN'S SUBDIVISION OF THE EAST ONE-HALF OF THE SOUTHWEST QUARTER OF SECTION 10, TOWNSHIP 11 NORTH, RANGE 25 WEST OF THE 6TH P.M., AND WITHIN THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA; RESERVING AN EASEMENT THEREIN; PROVIDING FOR THE REVERSION OF THE OWNERSHIP THEREOF; PROVIDING FOR AN EFFECTIVE DATE; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH:

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

1. The South 9.5 feet of 15th street, between the East line of Avenue F and the West line of Avenue G, and abutting Lots One and Twelve, Block 13 of Ehmen's Subdivision of the East one-half of the Southwest Quarter of Section 10, Township 11 North, Range 25 West of the 6th P.M., and within the City of Gothenburg, Dawson County, Nebraska, is hereby vacated subject to the terms, conditions and reservations of this ordinance.
2. The City hereby reserves an Easement over, across and through said property so vacated for the installation, maintenance and replacement of utilities including overhead and underground utility pipes, sewer, water, electrical lines, such other utilities as the City may deem appropriate to install, reinstall, maintain and replace.
3. The property so vacated shall revert to the abutting land owners.
4. All ordinances and parts of ordinances in conflict herewith are hereby repealed.
5. This ordinance shall become effective from and after its passage, approval and publication according to law.

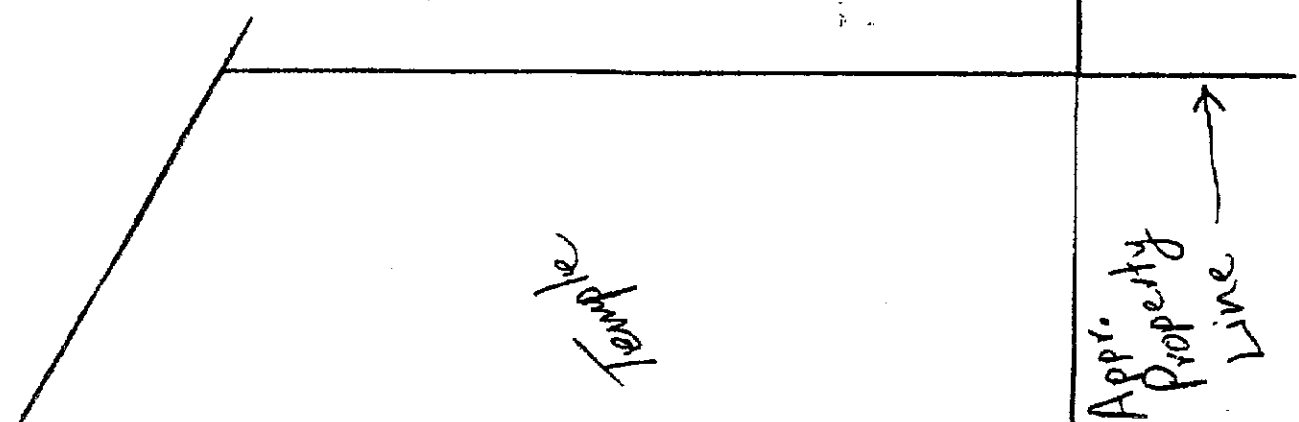

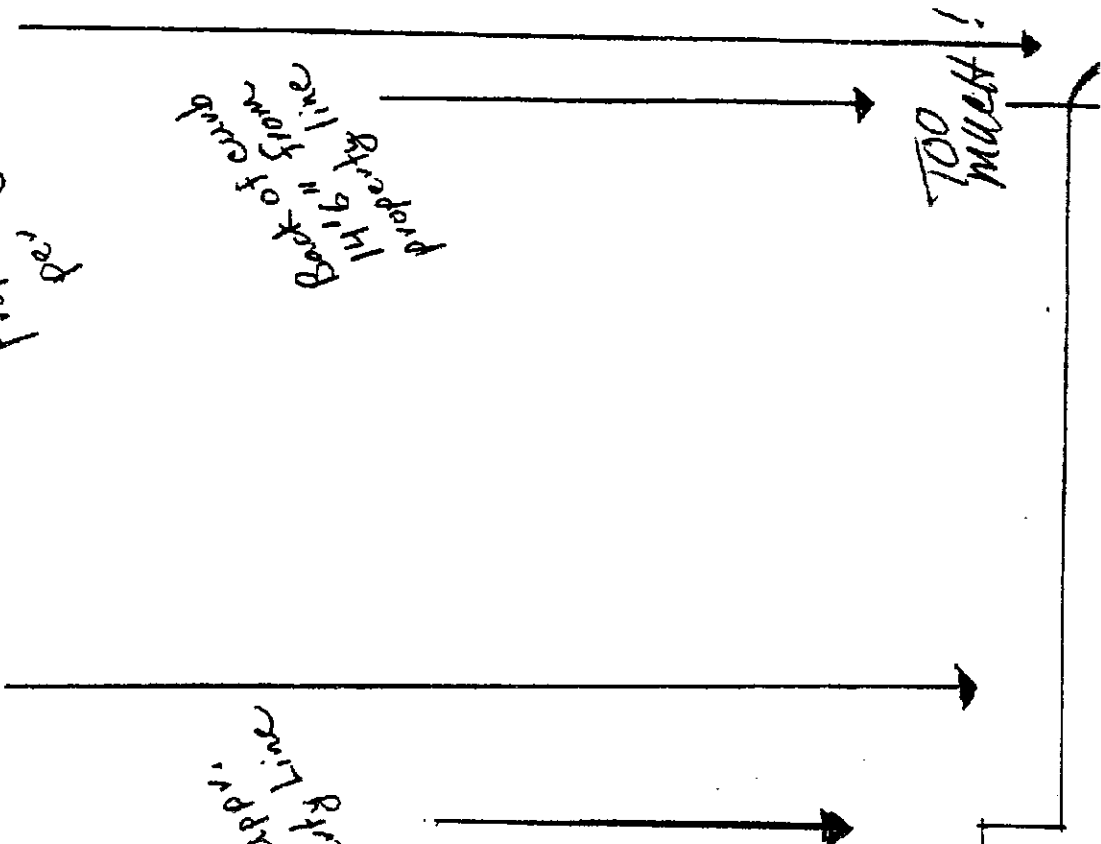
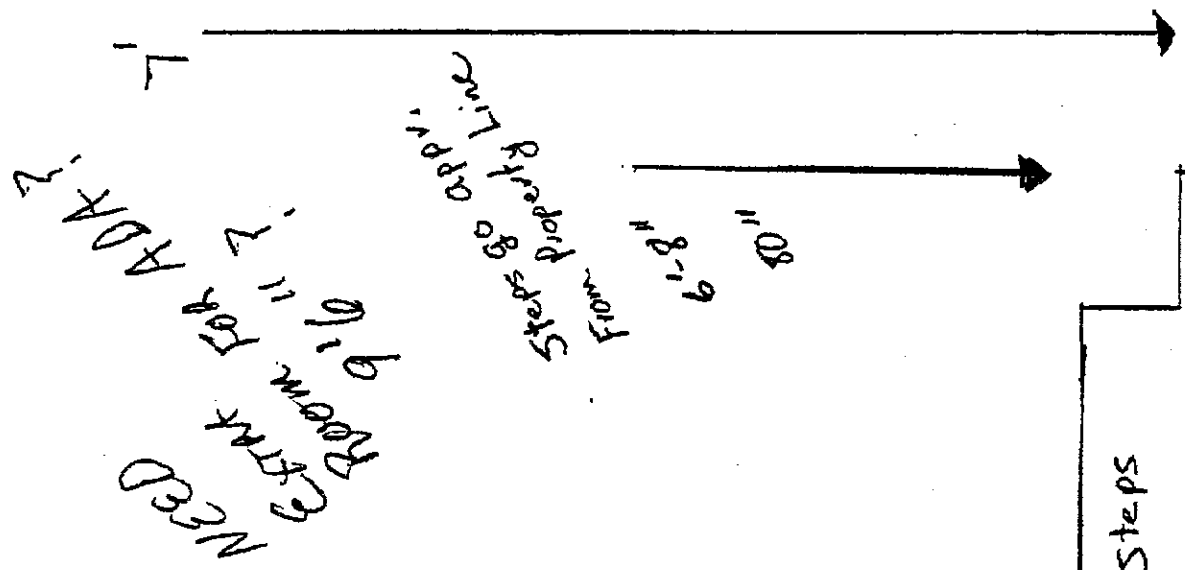
