

EXTRACTS FROM MINUTES OF A SPECIAL MEETING OF THE MAYOR AND COUNCIL OF THE CITY OF GOTHENBURG, NEBRASKA IN THE COUNTY OF DAWSON, STATE OF NEBRASKA, HELD IN THE COUNCIL ROOM IN SAID CITY ON THE 17TH DAY OF JULY, 1956, AT 8:00 O'CLOCK P. M. SHOWING THE PASSAGE OF A RESOLUTION AUTHORIZING THE CONVEYANCE OF A STRIP OF VACATED STRIP OF STREET, BY QUIT CLAIM DEED.

AND WHEREAS, there exists a strip of vacated street ten feet wide, on the North side of said above described real estate and contiguous thereto, and it is the intention of the City of Gothenburg, Nebraska, that said vacated strip be sold with the above described premises, and
