

TRANSCRIPT OF MINUTES AND PROCEEDINGS OF MAYOR
AND COUNCIL OF THE "CITY OF GOTHENBURG" HELD AT
THE REGULAR MEETING PLACE OF SAID MAYOR AND
COUNCIL ON JUNE 5, 1956 AT 8 O'CLOCK P.M.

At a regular meeting of the Mayor and Council of the
"city of Gothenburg" held in the Council Room of the City Hall
in Gothenburg, Dawson County, Nebraska on June 5, 1956 at 8
o'clock p.m., the following resolution was offered and its adop-
tion moved by Councilman Clarence Deaver.

RESOLUTION

WHEREAS at a special election held in the "city of
Gothenburg" on May 29, 1956, at which time the following pro-
position was submitted to the qualified electors of the "city
of Gothenburg", Nebraska:

Shall the "city of Gothenburg" by resolution
duly adopted by its governing body approve or
disapprove of the acquisition by the "city of
Gothenburg" of the electric distribution system
situated within said city and owned by Platte
Valley Public Power and Irrigation District, as
distinguished from its generating plants and
transmission lines, in accordance with the pro-
visions of Section 70-650.01, R.R.S. 1943,
Reissue of 1950, and by such resolution request
or refuse to request said district to convey all
of its right, title and interest in and to the same
to the "city of Gothenburg" without cost, said
system having been acquired by said district by
purchase, and the district having fully paid and
redeemed, and having accumulated reserves suffi-
cient for the redemption of all of the bonds
and other obligations of the district evidencing
the indebtedness incurred as the purchase price
of its lines, works and system.

WHEREAS at said special election the vote on said pro-
position by wards was as follows:

WHEREAS, the necessary vote required for the adoption and approval of said proposition at said election was a simple majority, and

WHEREAS, said proposition so voted upon was carried at said election by more than a majority.

NOW THEREFORE BE IT AND IT IS HEREBY RESOLVED by the Mayor and Council of the City of Gothenburg, Dawson County, Nebraska, that in accordance with and pursuance of the vote of the electors of said city at said special election on May 29, 1956, it is the duty of the Mayor and council of the "city of Gothenburg" to request the Platte Valley Public Power & Irrigation District to transfer and convey without cost to the "city of Gothenburg" all of its right, title and interest in and to its electric distribution system, as distinguished from its generating plants and transmission lines, within the territorial limits of said city in which said system is located.

BE IT AND IT IS HEREBY FURTHER RESOLVED that the Mayor and Council of the City of Gothenburg, Dawson County, Nebraska, in accordance with the vote of the electors of said city at said election hereby request that the Platte Valley Public Power & Irrigation District convey to the "city of Gothenburg", without cost, all its right, title and interest in and to its electric distribution system, as distinguished from its generating plants and transmission lines, within the territorial limits of said city in which said system is located.

BE IT FURTHER RESOLVED that said request is made in pursuance of Section 70-650.01 R.R.S. 1943, Reissue of 1950, said acquisition having been approved by the electors of such city in manner and form as provided by law, and after said Platte Valley Public Power & Irrigation District has fully paid and redeemed and has accumulated reserves sufficient for the redemption of all of

the bonds or other obligations of the District evidencing the indebtedness incurred as the cost of construction or the purchase price of its lines, works and system.

BE IT AND IT IS HEREBY FURTHER RESOLVED that said request on Platte Valley Public Power & Irrigation District for such conveyance shall be accomplished by the mailing to Platte Valley Public Power & Irrigation District at North Platte, Lincoln County, Nebraska a true and certified copy of said resolution as adopted by the Mayor and Council of said city at its meeting of June 5, 1956.

Councilman Emil Friesenborg
seconded the motion to adopt said resolution and the matter was put to a vote of the Council by the Mayor, and on roll call the following voted "Yea":
