

NOTICE OF THE CREATION OF PAVING AND IMPROVEMENT DISTRICTS  
NUMBERED 19, 20, 21, 23 and 24.

At a meeting of the Mayor and Council of the City of Gothenburg, Nebraska, held in the City Hall on the 17<sup>th</sup> day of May, 1956, the City Council of said city passed, approved and ordered published Ordinance No. 128, creating and establishing Paving and Improvement Districts numbered 19, 20, 21, 23 and 24.

Notice is hereby given that for the purpose of grading, regrading, curbing, recurbing, guttering, reguttering, paving, widening, resurfacing, and otherwise improving the streets located within the districts hereinafter described, there is hereby created the following described paving and improvement districts:

(A) Paving and Improvement District Number 19, being a portion of Avenue C (formerly known as Lake Street) from the North curb line of Eighteenth Street (formerly known as Beattie Street) to the South curb line of Twentieth Street (formerly known as Hatfield Boulevard), and said paving and improvement district shall comprise and include all the lots and parcels of land lying and being contained within the following described boundaries:

Commencing at a point on the South line of Twentieth Street, at a point being the center of the North (N) line of the vacated strip of street adjacent to the north side of Block Twenty-six (26), in Lake View Addition to the City of Gothenburg, Dawson County, Nebraska; thence West along the South curb line of the said Twentieth Street to a point being the center of the North (N) line of the vacated strip of street adjacent to the North side of Block Twenty-five (25) in Lake View Addition to the City of Gothenburg, Dawson County, Nebraska; thence South to a point being the center of the South line of Block Two (2) of Jackson & Bothwell's Addition to Gothenburg, Dawson County, Nebraska, thence East to the Southeast corner of Lot Two (2), Block One (1), Jackson & Bothwell's Addition to Gothenburg, Dawson County, Nebraska; thence North to the Northeast corner of Lot Six (6) to Carlson's Addition to Gothenburg, Dawson County, Nebraska; thence East a distance of ten (10) feet to the center of the alley through Carlson's Addition to Gothenburg, Dawson County, Nebraska; thence North to a point ~~be~~ the North line of the vacated strip adjacent to the North side

of Block Twenty-six (26), Lake View Addition to Gothenburg, Dawson County, Nebraska, the same being the center of said north line and the same being the place of beginning.

(B) Paving and Improvement District Number 20, being a portion of Ninth Street (formerly known as Second Street) from the East curb line of Avenue F (formerly known as First Street) to the West curb line of Avenue G (formerly known as C Street and Second Avenue), and said paving and improvement district shall comprise and include all the lots and parcels of land lying and being contained within the following described boundaries:

Commencing at the Northwesterly corner of Lot Seven (7), Block Three (3), Original Town, now City of Gothenburg, Dawson County, Nebraska, thence Southwesterly to the Southwesterly corner of Lot Six (6), Block Six (6), of the said Original Town of Gothenburg, thence Southeasterly to the Southeasterly corner of Lot One (1) of the said Block Six (6) of the said Original Town, now City of Gothenburg; thence Northeasterly to the Northeasterly corner of Lot Twelve (12), Block Three (3) of the said Original Town, now City of Gothenburg, thence Northwesterly to the place of beginning.

(C) Paving and Improvement District Number 21, being Avenue B (formerly known as State Street) from the North curb line of Tenth Street (formerly known as Third Street) to the South curb line of Sixteenth Street (formerly known as Fourth Avenue and Hunter Street), and said paving and improvement district shall comprise and include all the lots and parcels of land lying and being contained within the following described boundaries:

Commencing at the Southeast corner of Lot Six (6) in Block Fifteen (15), West Lawn Addition to the City of Gothenburg, Dawson County, Nebraska, thence Westerly along the South line of said Lot Six (6) to the Southwest corner thereof; thence North to the Northwest corner of Lot One (1), Block Six (6) of West Lawn Addition to the City of Gothenburg, Dawson County, Nebraska; thence East to the Northeast corner of Lot Twelve (12), Block Seven (7), West Lawn Addition to the City of Gothenburg, Dawson County, Nebraska; thence South to the Southeast corner of Lot Four (4), Church Park Addition to the City of Gothenburg,

Dawson County, Nebraska; thence West to the Southwest corner of the said Lot Four (4) of Church Park Addition to the City of Gothenburg, Dawson County, Nebraska, thence Northwesterly to the place of beginning.

(D) Paving and Improvement District Number 23, being Twenty-second Street (formerly known as Hazel Street) from the West curb line of Grand Avenue to the East curb line of Avenue F (formerly known as First Street) and Avenue F (formerly known as First Street) from the North curb line of Twenty-second street (formerly known as Hazel Street) to the South curb line of Twenty-third Street (formerly known as Willow Street), and said paving and improvement district shall comprise and include all ~~the~~lots and parcels of land lying and being contained within the following described boundaries:

Commencing at the Northeast corner of Lot One (1), Block Seventeen (17), Lake View Addition to the City of Gothenburg, Dawson County, Nebraska, thence Northeasterly to the Southeast corner of Lot Six (6), Lake View Second Addition to the City of Gothenburg, Dawson County, Nebraska; thence Northerly to the Southeast corner of Lot Three (3), Lake View Second Addition to the City of Gothenburg, Dawson County, Nebraska; thence Easterly to the Southwest corner of Lot Five (5), Lakeside Second Addition to the City of Gothenburg, Dawson County, Nebraska; thence Easterly to the Southeast corner of the said Lot Five (5), Lakeside Second Addition to the City of Gothenburg, Dawson County, Nebraska; thence Northerly to the Northeast corner of Lot Three (3) of the said Lakeside Second Addition to the City of Gothenburg, Dawson County, Nebraska; thence Easterly along the North line of Lots One (1) and Two (2) to the Northeast corner of Lot One (1) in Lakeside Second Addition to Gothenburg, Dawson County, Nebraska; thence Northeasterly to the Northwest corner of Lot Twenty-one (21), of the Subdivision of Blocks Thirteen (13) and Fourteen (14), Lake View Addition to the City of Gothenburg, Dawson County, Nebraska; thence East to the Northeast corner of said Lot Twenty-one (21); thence South to the Southeast corner of Lot Twenty-six (26) of the Subdivision of Blocks Thirteen (13) and Fourteen (14), Lake View Addition to the City of Gothenburg, Dawson County, Nebraska; thence West to the Southwest corner of said Lot Twenty-six (26); thence South to the Northwest corner of

Lot Ten (10), Block Nineteen (19), Lake View Addition to the City of Gothenburg, Dawson County, Nebraska; thence West to the Northeast corner of Lot One (1), Block Eighteen (18), Lake View Addition to the City of Gothenburg, Dawson County, Nebraska; thence South to the Southeast corner of the said Lot One (1), Block Eighteen (18), Lake View Addition to the City of Gothenburg, Dawson County, Nebraska; thence West to the Southwest corner of Lot Five (5), Block Eighteen (18), Lake View Addition to Gothenburg, Dawson County, Nebraska; thence Northerly along the west line of said Lot Five (5), Block Eighteen (18) of Lake View Addition to the Northwest corner of said Lot Five (5); thence West to the place of beginning.

(E) Paving and Improvement District Number 24, being Twentieth Street (formerly known as Hatfield Boulevard) from the East curb line of Avenue F (formerly known as First Street) to the West curb line of Avenue G (formerly known as Second Avenue) and said paving and improvement district shall comprise and include all the lots and parcels of land lying and being contained within the following described boundaries:

Commencing at the Southwest corner of the vacated strip adjacent to the South end of Lot Eleven (11), Block Twenty (20), Lake View Addition to the City of Gothenburg, Dawson County, Nebraska, thence North to the Northwest corner of said Lot Eleven (11), Block Twenty (20), Lake View Addition to Gothenburg, Dawson County, Nebraska; thence East to the Northeast corner of Lot Twenty (20), Block Twenty (20), Lake View Addition to the City of Gothenburg, Dawson County, Nebraska; thence South to the Southeast corner of Lot One (1), Block Twenty-nine (29), Lake View Addition to Gothenburg, Dawson County, Nebraska; thence West to the Southwest corner of Lot Ten (10), Block Twenty-nine (29), Lake View Addition to the City of Gothenburg, Dawson County, Nebraska; thence North to the place of beginning.

If a majority of the resident owners of the property directly abutting on the streets included in any of said above described districts shall file with the City Clerk of said City, within 20 days after the 7<sup>th</sup> day of JANUARY, 1956, written objections to the creation of said paving and improvement district, said improvement shall not

be made with reference to the said district or districts to which said objections have been made and Ordinance Number 128 creating said district or districts to which objections are made, shall be repealed in so far as said district or districts are concerned.
