

RESOLUTION 246

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF GOTHENBURG, NEBRASKA:

Section 1.

Whereas, in Pavement Improvement District #29, the unpaid assessments for paving in the amount of \$689.76 are duly assessed to Lots One (1) and Two (2), and the North Forty-seven Feet (N 47') of Lot Three (3) in the Subdivision of Blocks Thirteen (13) and Fourteen (14), of Lakeview Addition to the City of Gothenburg, Dawson County, Nebraska, and

Section 2.

Whereas, said property has been divided so that the ownership of all that portion described as follows, to-wit:

Lot One (1) and the North Eighteen Feet (N 18') of Lot Two (2) in the Subdivision of Blocks Thirteen (13) and Fourteen (14) of Lakeview Addition to the City of Gothenburg, Dawson County, Nebraska,

and that portion thereof described as:

The South Thirty-two Feet (S 32') of Lot Two (2), and the North Forty-seven Feet (N 47') of Lot Three (3), in the Subdivision of Blocks Thirteen (13) and Fourteen (14) of Lakeview Addition to the City of Gothenburg, Dawson County, Nebraska,

are respectively owned by separate parties,

Section 3.

Whereas, in Paving Improvement District # 29, the unpaid assessment for paving in the amount of \$855.73 are duly assessed to Lots Nine (9), Ten (10) and the South Thirty Feet (S 30') of Lot Eleven (11), of the Subdivision of Block Thirty (30) of Summit Addition to Gothenburg, Nebraska.

Section 4.

Whereas, the last above described property has been divided so that the ownership of that portion thereof described as follows:

Lot Nine (9) and the South Twenty Feet (S 20') of Lot Ten (10) of the Subdivision of Block Thirty (30) of Summit Addition to Gothenburg, Nebraska,

and that portion thereof described as:

The North Thirty Feet (N 30') of Lot Ten (10) and the South Thirty Feet (S 30') of Lot Eleven (11) of the Subdivision of Block Thirty (30) of Summit Addition to Gothenburg, Nebraska,

are respectively owned by separate parties.

Section 5.

Whereas, it is hereby ordered that the assessments above related be divided as follows, to-wit:

Lot One (1) and the North Eighteen Feet (N 18') of Lot Two (2) in the Subdivision of Blocks Thirteen (13) and Fourteen (14) of Lakeview Addition to the City of Gothenburg, Dawson County, Nebraska: 342.68

The South Thirty-two Feet (S 32') of Lot Two (2), and the North Forty-seven Feet (N 47') of Lot Three (3), in the Subdivision of Blocks Thirteen (13) and Fourteen (14) of Lakeview Addition to the City of Gothenburg, Nebraska: 347.08

Lot Nine (9) and the South Twenty Feet (S 20') of Lot Ten (10) of the Subdivision of Block Thirty (30) of Summit Addition to Gothenburg, Nebraska: 460.99

The North Thirty Feet (N 30') of Lot Ten (10) and the South Thirty Feet (S 30') of Lot Eleven of the Subdivision of Block Thirty (30) of Summit Addition to Gothenburg, Nebraska: 394.74
