RESOLUTION CREATING SANITARY SEWER DISTRICT No. 16

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA:

SECTION 1. Whereas, the Mayor and City Council of the City of Gothenburg, Nebraska, deem it advisable and necessary to construct a Sanitary Sewer District as hereinafter provided and that for the purpose of such construction, Sanitary Sewer District No. 16 is hereby created in the City of Gothenburg, Dawson County, Nebraska.

SECTION 2. That Sanitary Sewer District Number 16 shall include 6th Street from the center of Avenue C to the center of Avenue A; Avenue B from the center of 6th Street to the center of 5th Street; Avenue A from the center of 6th Street to the center of 7th Street; 7th Street from the center of Avenue A to the West line of Hiles & Reynold's Addition to the City of Gothenburg, Dawson County, Nebraska, and real estate one-half block on each side of said portion of 6th Street from Avenue C to Avenue A; Avenue B from 6th Street to 5th Street; Avenue A from 6th Street to 7th Street and 7th Street from Avenue A to the West line of Hiles and Reynold's Addition to the City of Gothenburg, Dawson County, Nebraska, said real estate being described as follows:

Beginning at the Southeast corner of Lot 1, Block 7 of Hiles and Reynold's Addition to the City of Gothenburg, Dawson County, Nebraska; thence Northwesterly to the center of the North line of the alley extending through said Block 7; thence South to the South line of said Block 7; thence Northwesterly to the center of the South line of Block 8 of Hiles & Reynold's Addition to Gothenburg, Dawson County, Nebraska; thence Northeasterly to the center of the North line of the alley extending through the said Block 8; thence Northwesterly to the Southwest corner of Lot 6 in Block 9 of Hiles and Reynold's Addition; thence Northeasterly to the Southwest corner of Lot 6 of Block 5 of said Hiles & Reynold's Addition; thence Northwesterly along the North alley line of Blocks 5, 4, and 3 to the West line of said Hiles and Reynold's Addition; thence North along the

West line of said Hiles and Reynold's Addition, extended to the center of the Union Pacific Railroad Right-of-Way; thence, Southeasterly along the center line of the said Union Pacific Railroad right-of-way to the West line of the Platte Valley Public Power and Irrigation District tailrace right-of-way; thence, South along said Platte Valley Public Power and Irrigation District tailrace right-of-way to the East line of said Lot 1, Block 7 of said Hiles & Reynold's Addition to the place of beginning.

SECTION 3. That said sewer shall be laid in 6th Street from Avenue C to Avenue A, Avenue A from 6th Street to 7th Street and 7th Street to the West line of Hiles & Reynold's Addition and in accordance with the General Sewer Plans adopted by the Mayor and City Council of said City insofar as they can be carried out.

SECTION 4. That said sewer extension in the above described district shall be constructed of Eight Inch Vitrified Clay Pipe and shall be laid according to the plans and specifications of the City Engineer on file in the office of the City Clerk of said City. The estimated cost of the construction of said district being \$7,806.04.

SECTION 5. That upon completion of the construction of said sewer district, the cost shall be finally determined by the City Council and the same shall be levied and assessed by the said City Council upon the property specifically benefited thereby within said district as required by law and in the manner provided by law, and upon said levy and assessment being determined, the same shall become due and delinquent as provided by law.


SECTION 6. That this Resolution shall become operative after notice as required by law and that notice of hearing in connection with the adoption of this Resolution shall be given by publication for two consecutive weeks in the Gothenburg Times, a newspaper of general circulation published in the City of Gothenburg, Nebraska.

SECTION 7. That a hearing on said Resolution shall be held on the 19th day of December, 1961, at the hour of 8 o'clock P. M. in the council room in the City Hall in the City of Gothenburg, Dawson

County, Nebraska.

SECTION 8. That any petition in opposition to said Resolution must be filed with the City Clerk within 3 days before the date of the hearing on such Resolution

Said Resolution approved and publication ordered as provided by law this 21st day of November, 1961.
