RESOLUTION CREATING SANITARY SEWER DISTRICT No. 17.

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOTHENBURG,

DAWSON COUNTY, NEBRASKA:

Section 1.

Whereas, the Mayor and City Council of the City of Gothenburg, Nebraska, deem it advisable and necessary to construct a Sanitary Sewer District as hereinafter provided and that for the purpose of such construction, Sanitary Sewer District No. 17 is hereby created in the City of Gothenburg, Dawson County, Nebraska.

Section 2.

That Sanitary Sewer District Number 17 shall include Highland Drive from the Center of Avenue F to the intersection of a line being a projection of the center line of Northaven Drive, Northaven Drive from the center of Highland Drive to the Center of Avenue F, Avenue F from the intersection of a projection of the center line of Northaven Drive to the center of the intersection of Avenue F, Grand Crescent Avenue and 24th Street; and 24th Street from the intersection last above described to the center of Avenue G, known as Part A of said district and the outer boundaries of the real estate in which it is proposed to make special assessments is described as follows, to-wit:

The outside boundary of all of Northaven Heights, Second Subdivision to the City of Gothenburg, Nebraska, and real estate described as beginning at the Southwest corner of the Subdivision of Blocks 7 and 8 of Lakeview Addition to the City of Gothenburg, Nebraska; thence North to a point 50 feet North of the Northwest corner of said Subdivision; thence East to a point 50 feet North of the Northeast corner of Lot 9 of said Subdivision; thence South to the Southeast corner of Lot 10 of said Subdivision; thence West to the place of beginning.

That Sanitary Sewer District Number 17 shall further include 22nd Street from the center of Avenue G to the center of Avenue H; Avenue H from the center of 22nd Street to the Center of 20th Street; 20th Street from the Center of Avenue H to the Center of Avenue I; Avenue I from the center of 20th Street to the Center of 19th Street; all referred to as Part B of said District and the outer boundaries of real estate in which it is proposed to make special assessments are as follows, to-wit:

Commencing at the Northeast corner of Lot 6 in Block 31, Summit Addition to the City of Gothenburg, Nebraska; thence South to the Southeast corner of Lot 18 in said Block 31; thence south to the south boundary of that portion of 20th Street previously vacated; thence East parallel to the South boundary of Block 41, of said Summit Addition to a point opposite the Southeast corner of Lot 18 of said Block 41, thence North to the Northwest corner of Lot 6, Block 32 of said Summit Addition; thence West to the place of beginning.

Section 3.

That said sewer shall be laid in Highland Drive from Avenue F to Northaven Drive; Northaven Drive from Highland Drive, north and east to Avenue F; Avenue F from Northaven Drive to 24th Street; 24th Street from Avenue F to Avenue G, as to Part A; and 22nd Street from Avenue G to Avenue H; Avenue H from 22nd Street to 20th Street; 20th Street from Avenue H to Avenue I; Avenue I from 20th Street to 19th Street, as to Part B.

Section 4.

That said sewer extension in the above described district shall be constructed of Eight-inch Vitrified Clay Pipe and shall be laid according to the plans and specifications of the City Engineer on file in the office of the City Clerk of said City. The estimated cost of the construction of said district being \$\_\_\_\_\_.

Section 5.

That upon completion of the construction of said sewer district, the cost shall be finally determined by the City Council and the same shall be levied and assessed by the said City Council upon the property specifically benefited thereby within said district as required by law and in the manner provided by law, and upon said levy and assessment being determined, the same shall become due and delinquent as provided by law.

Section 6.

That this Resolution shall become operative after notice as required by law and that notice of hearing in connection with the adoption of this Resolution shall be given by publication for two consecutive weeks in the Gothenburg Times, a newspaper of general circulation published in the City of Gothenburg, Nebraska.

Section 7.

That a hearing on said Resolution shall be held on the \_\_\_\_ day of January, 1968, at the hour of 8 o'clock P.M., in the council room in the City Hall in the City of Gothenburg, Dawson County, Nebraska.

Section 8.

That any petition in opposition to said Resolution must be filed with the City Clerk within 3 days before the date of hearing on such Resolution.
