

RESOLUTION

The Mayor and Council of the City of Gothenburg, Dawson County, Nebraska, met in regular session in the Council Chambers in said City on the 20th day of April at 7:30 o'clock P. M.

Mayor M. J. Ayres presided and City Clerk Jane Ballmer recorded the proceedings. Upon roll call, the following Councilmen were present: *Arlo Haggitt, Gerald Woodcock, Carlyle Williams, and Jean Gledyger*

A quorum being present and the meeting duly convened, the following proceedings were had and done:

Councilman *Woodcock* offered the following Resolution and moved its adoption:

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOTHENBURG, NEBRASKA:

Section 1. The Mayor and Council hereby find and determine that it is necessary and advisable that the City, under the authority granted by Sections 18-2001 to 18-2003 inclusive, Issue Revised Statutes of Nebraska, 1943 as amended, without petition or creating a street improvement district under Article 5 of Chapter 17 of said Statutes, cause the following unpaved streets within the City to be improved by grading, curbing, guttering and paving, together with necessary appurtenances, to wit:

Avenue B for a distance of 1 block between U. S. Highway #30 and 9th Street which improvement shall be known as Street Improvement No. 10.

Avenue B for a distance of 1 block between 16th and 17th Streets which improvement shall be known as Street Improvement No. 11.

24th Street for a distance of 1 block between Lake Avenue and Grande Avenue which improvement shall be known as Street Improvement No. 12.

Grande Avenue for a distance of 1 block between 22nd Street and 23rd Street which improvement shall be known as Street Improvement No. 13.

23rd Street for a distance of 1 block between Lake Avenue and Grande Avenue which improvement shall be known as Street Improvement No. 14.

Section 2. It is found and determined that each of the above streets to be improved in Street Improvement Nos. 10 to 14 inclusive, intersect a paved street.

Section 3. The paving improvements in Street Improvement Nos. 10 to 14 inclusive be and the same are hereby ordered constructed, and that the plans and specifications of the Engineer for the City for the construction of the above street improvements, which are on file with the City Clerk, are hereby approved and the Clerk is instructed to cause Notice to Bidders to be published as provided by law for receiving bids. For the purpose of constructing the improvements in Street Improvement Nos. 10 to 14 inclusive, such improvements may be combined and awarded in one contract for construction and may be combined with paving districts created in the City, but the actual cost of construction of each of the projects shall be performed in such manner that the costs may be allocated to each project for the purpose of levying any authorized special assessments.

The notice to bidders and the combinations of projects shall be in the manner provided in Section 19-2401, Revised Statutes, Supplement, 1963.

Section 4. The costs of such grading, curbing and guttering and paving, together with necessary appurtenances shall be assessed against each lot and parcel of real estate adjacent to or abutting upon the portion of street or alley thus improved or which may be specially benefited by such improvement.

The foregoing resolution having been read, Councilmen *GARRATT* seconded the motion for its passage and adoption, and after consideration thereof, the roll was called on the passage and adoption of said resolution and the following Councilmen voted "AYE": *Gallagher, Williams, GARRATT, Nordbrack;*  
"NAY": *None*

A majority of all members elected to the Council having voted in favor of the passage and adoption of said resolution, the same was by the Mayor declared passed and adopted.
