

City Councilman Fickenscher offered the following resolution and moved its adoption.

RESOLUTION

Creating a Joint Airport Zoning Board
in accordance with Section 3-304, R. R. S. 1943.

Be it resolved by the Mayor and City Council of Gothenburg,
Nebraska that:

I.

It is hereby found and determined that:

1. The Gothenburg Municipal Airport is an airport owned by this city and operated by the Gothenburg Airport Authority and is located adjacent to the east side of Gothenburg and outside the corporate limits of the City.
2. The area of land and water extending out in all directions a distance of three miles from the adjacent boundaries of said airport constitutes an airport hazard area within the meaning of Sec. 3-304 (3), R.R.S. 1943.
3. The airport hazard area, appertaining to the above mentioned airport, is located partially within the County of Dawson and partially within the area that is controlled by zoning regulations of the City of Gothenburg, Nebraska.
4. It is necessary and expedient that the City of Gothenburg, the political subdivision owning the above named airport, and the County of Dawson, the political subdivisions within which a part of the airport hazard area is located, create a Joint Airport Zoning Board in accordance with Sec. 3-304, R.R.S. 1943.

II.

The City of Gothenburg does hereby participate with the County of Dawson in the creation of a Joint Airport Zoning Board, to be known as

Gothenburg Joint Airport Zoning Board, and to that end there is hereby created the Gothenburg Joint Airport Zoning Board, which board shall have and exercise all the powers conferred, and perform all the duties enjoined upon it by the Airport Zoning Act.

III.

Loren Taylor and Dean Kugler, residents of the City of Gothenburg, are hereby appointed as members of the Gothenburg Joint Airport Zoning Board, to represent the city thereon.

The foregoing resolution having been fully and distinctly read aloud, the motion for its adoption was seconded by Councilman Wahlgren. On roll call the vote was as follows: Yea: Quatt, Wahlgren, Nichols, and Fickenscher; Nay: None. Whereupon the Mayor declared the resolution adopted.
