RESOLUTION 1988 - 2

WHEREAS the City Council of the City of Gothenburg, Dawson County, Nebraska has been presented with a proposal to authorize the sale of beer and wine on Sundays; and

WHEREAS the Mayor and Council of the City of Gothenburg deem it in the best interest of said City to refer said request to the electors of the City of Gothenburg.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

Section 1. The following proposition shall be submitted to the electors of the City of Gothenburg, Dawson County, Nebraska at the primary election, next held after the passage of this resolution, to-wit: Shall the sale of beer and wine, by the package, be authorized in the City of Gothenburg, Dawson County, Nebraska on Sundays between the hours of <sup>10:00</sup>12:00 p.m. and 5:00 p.m.?
