

RESOLUTION 1990- 24

WHEREAS, the City Council of the City of Gothenburg, Dawson County, Nebraska has previously expressed its intention to promote the economic development and economic redevelopment of the City of Gothenburg, and said City Council favors a municipal sales tax to support economic development and economic redevelopment.

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

Section 1. That the City shall hold a special election on the 12th day of February, 1991, at which the issue set forth in Section 2 hereof shall be submitted to the electors of the City of Gothenburg.

Section 2. The issue submitted to the electors of the City of Gothenburg at the special election on February 12, 1991 is as follows: Shall the governing body of the City of Gothenburg, Nebraska impose a sales and use tax upon the same transactions within such municipality on which the State of Nebraska is authorized to impose a tax? If a majority of the votes cast upon such question shall be in favor of such tax then the governing body of such incorporated municipality shall be empowered as provided by Section 77-27,142 and shall forthwith proceed to impose a tax pursuant to the local option revenue act. If a majority of those voting on the question shall be opposed to such tax, then the governing body of the incorporated municipality shall not impose such tax.

The sales and use tax imposed shall be at the rate of 1/2 percent and shall commence on April 1, 1991. The proceeds of such tax shall be used for community economic development and community redevelopment as determined by the Gothenburg City Council.


