

RESOLUTION 1993 - 11

A special election is hereby called and shall be held in the City of Gothenburg, Dawson County, Nebraska on October 14, 1993, at which election there shall be submitted to the qualified electors of the City the following question:

"Shall the City of Gothenburg, Nebraska, issue the negotiable bonds of the City in the principal amount of not to exceed Three Hundred Eighty Thousand Dollars (\$380,000.00) for the purpose of making additions, repairs and improvements to and acquiring equipment for the Gothenburg Municipal Swimming Pool, said Bonds to be dated at the time of their issuance, to become due and payable on such dates as may be fixed by the Mayor and City Council of the City of Gothenburg at the time their issuance and said Bonds to bear interest from date of issuance at such rate or rates to be determined by the Mayor and City Council, provided, however, that the City will not issue Bonds for the purposes specified herein unless the electors of the City shall approve an additional one-half percent sales and use tax on transactions within the City, the proceeds of which shall be used to pay for the principal, interest, costs of issuance and all related costs of the Bonds to be issued pursuant hereto; and

shall the City cause to be levied and collected annually a special levy of taxes against all of the taxable property in the City sufficient in rate and amount to pay the principal and interest on said Bonds as such principal and interest become due and payable, to the extent necessary in addition to the proceeds of the sales tax levied for such purposes?"

The ballots to be voted shall set forth the above proposition stated, followed by the words "YES (FOR SAID BONDS AND TAX)" and "NO (AGAINST SAID BONDS AND TAX)" with a square opposite each. Voters desiring to vote in favor of said proposition shall mark an "X" in the square receding the word "YES", voters desiring to vote against said proposition shall mark an "X" preceding the word "NO".


Polls for voting at said election shall remain open from 8:00 a.m. to 8:00 p.m. Central Daylight Savings Time, on said date and the polling places shall be designated the Election Commissioner of Dawson County, Nebraska, as provided by law.

The City Clerk is hereby authorized and directed to certify a copy of this resolution to the Election Commissioner of Dawson County, who shall designate the polling places, appoint the election officials and otherwise conduct the election as provided by law. The City agrees to reimburse the Election Commissioner for all expenses incurred in conducting the election.


The City Clerk is hereby authorized and directed, in conjunction with the Election Commissioner conducting the election, to arrange for the printing of the necessary ballots for said election appropriate or necessary in order to cause said proposition to be submitted to the qualified electors of the City as above provided. The City Clerk is also directed to publish notice of said election in **The Gothenburg Times** in at least four issues and to cause a sample ballot to be published in **The Gothenburg Times** not more than ten nor less than three days prior to the election.
