RESOLUTION 1995 - 8

WHEREAS, the City of Gothenburg, Nebraska, a municipal corporation and city of the second class, has determined that it is in the best interest of the City to retain the local option sales tax; and

WHEREAS, the City of Gothenburg has used this tax extensively and successfully for the purpose of economic development within the City; and

WHEREAS, the City of Gothenburg has made a commitment toward further economic development and such development depends upon the use of sales tax; and

WHEREAS, the City of Gothenburg's loss of local option sales tax would be most detrimental to the growth and expansion of a thriving community; and

WHEREAS, the City of Gothenburg has also recently passed a bond issue, and passed the local option sales tax as the commitment for repayment of this bond issue, to make much needed renovations to the City swimming pool; and

WHEREAS, the City of Gothenburg swimming pool project would be in serious jeopardy of not being able to fund the repayment of such bonds, if such legislation were to be passed that would remove the local option sales tax; and

WHEREAS, the City of Gothenburg plans to further use the local option sales tax to further its economic and community development.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOTHENBURG, NEBRASKA:

1. That it is hereby found and determined that LB 606 will seriously impact the City of Gothenburg and cause irreparable financial damage to the programs and missions approved by the voters of this City.
2. That the City of Gothenburg hereby vigorously opposes LB 606 and any other attempt by the State of Nebraska to take away local option sales tax funding.
