

RESOLUTION 1996- 11

WHEREAS signed Petitions have been filed with the City Clerk of the City of Gothenburg, Dawson County, Nebraska seeking to prohibit the introduction of fluoride into the municipal water system; and

WHEREAS the City of Gothenburg is obligated to provide for the verification of the signatures on said Petition, by law;

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

Section 1. Signed Petitions having been filed with the City Clerk of Gothenburg, Dawson County, Nebraska calling for a vote at the General Election concerning fluoridation of the Gothenburg municipal water supply, the City Council is required to pass a resolution providing for the verification of the signatures on said Petitions.


Section 2. The Dawson County Clerk is hereby requested, pursuant to Section 18-2518 of the Nebraska Revised Statutes to verify and count the signatures on said Petitions.

Section 3. The City of Gothenburg shall reimburse the County of Dawson for cost incurred by the Dawson County Clerk and providing such count and verification.


