
Gothenburg, Nebraska. Such property shall be sold as separate vehicle to the highest bidder at such auction and subject to the right of the City of Gothenburg to reject any and all such bids for the sale of such personal property. Such public auction shall be further subject to the right of remonstrance of the public. The successful bidder at such sale shall be required to deposit 20% of the bid price with the Clerk, and conveyance of the property will be by Bill of Sale within 10 days from and after said auction.

Section 4. The clerk is hereby directed to publish notice of the proposed sales and in The Gothenburg Times once each week for three consecutive weeks.


Section 5. If a remonstrance against such sale, or any of them is signed by legal electors of the City of Gothenburg equal in number to 30% of the electors of the City of Gothenburg voting at the last regular municipal election held, is filed with the governing body of the City of Gothenburg within 30 days after the third publication of such notice, the property shall not then, nor within one year thereafter be sold.

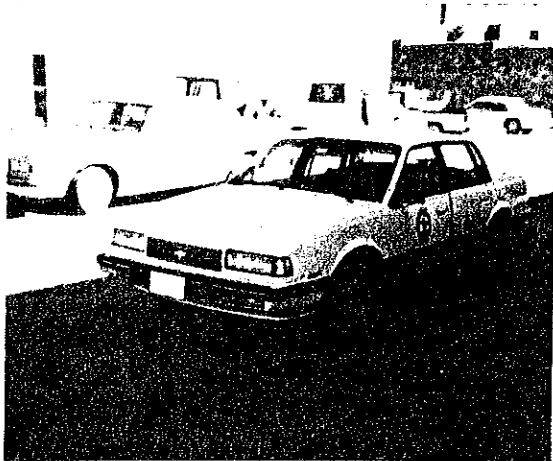

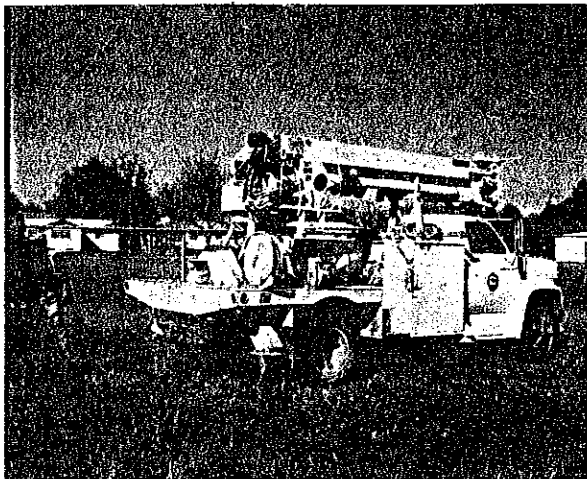

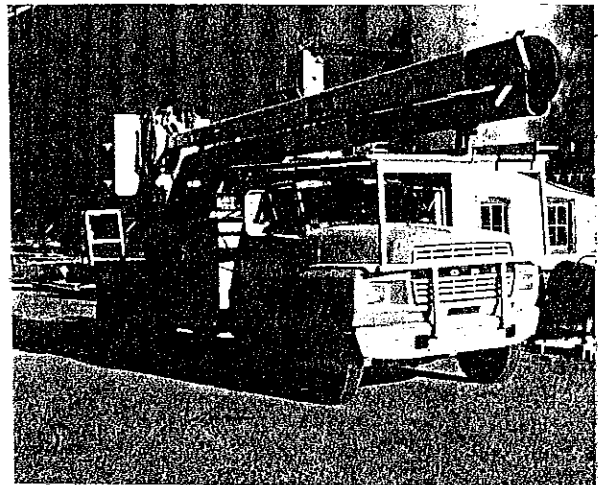
