ADOPTING TRASH COLLECTION RATES.


WHEREAS, the City Council of the City of Gothenburg deems it appropriate to approve the



City will retain \$.20 for billing and collection. Schaben's will retain \$.80 for Recycling City will bill as directed by Franchisee(s).

The City must be advised of billing changes by the 25th of the month, effective the first of the following month. City will reimburse Franchisee(s) after the second council meeting of the month.

Industry Rates

- Because of the special nature of the product from industry, the haulers will negotiate the terms individually with industries.
- An industry is defined for this purpose as a manufacturing plant that employs at least 30 people.
- Haulers will bill each industry individually for service.
- Industries within the City limits will be required to negotiate with only haulers who have franchised with the City.

Park Rates

Franchisee(s) will rent out to the City \$10.00/Month/Dumpster and \$5.00/ Month/Roll-Out for use in the City Parks.

- All containers must have lids or covers.
- No pickup or delivery to landfill on the items: Grass clippings, trees, shrubbery, leaves, garden waste, asbestos, and building material, except small pieces of wood or branches up to 3' in length.
- Any pickups outside of container to be billed at extra charge and collected by hauling company.
- If trash not taken for any reason, tag containers.
- Pickup maximum of six (6) times per week.
- Annual charge with payments monthly.
- Any service in a month will be billed at the monthly rate.

Adjustments quarterly to the above rates:

1. For each \$.50 increase or decrease in fuel above base of \$1.25 an increase or decrease of \$.35 will be made per month.
2. For each \$.50 increase or decrease in Lexington landfill fees, add or deduct \$.25.
