Section 2. The above described personal property shall be sold on the 19th day of August, 1999 by public auction at City Hall at the hour of 5:30 p.m.

Section 3. Following the passage of the Resolution, the clerk shall post notice of the proposed sale in three prominent places within the city for a period of not less than 7 days prior to the sale of the property. The notice shall give general description of the property offered for sale and state the terms and conditions of sale.

Section 4. The property shall be sold "as is" without warranties of any kind expressed or implied; and each item of property is declared to be of less value than \$5,000.00.

Section 5. Payment in full shall be required by good funds at the completion of the auction.
