<ul style="list-style-type: none"> - All containers must have lids or covers. - No pickup or delivery to landfill on the items: Grass clippings, trees, shrubbery, leaves, garden waste, asbestos, and building material, except small pieces of wood or branches up to 3' long. - Any pickups outside of container to be billed at extra charge and collected by hauling company. 	<ul style="list-style-type: none"> - If trash not taken for any reason, tag containers. - Pickup maximum of six (6) times per week. - Annual charge with payments monthly. - Any service in a month will be billed at the monthly rate.
