

RESOLUTION NO. 2008- 7

RESOLUTION DIRECTING THE SALE OF CERTAIN PERSONAL PROPERTY AT PUBLIC AUCTION AND ESTABLISHING THE MANNER AND TERMS THEREOF.

WHEREAS, the Mayor and City Council of the City of Gothenburg deem the personal property hereafter described to be excess and no longer of use or benefit to the City of Gothenburg; and

WHEREAS, the Mayor and City Council of the City of Gothenburg deem it appropriate to offer for sale the property hereafter described by public auction.

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

Section 1: Personal property described on attached Exhibit A shall be sold to at public auction at the Brott Auction Company Consignment Auction held in the City of Gothenburg, Nebraska, on March 29, 2008. The property shall be sold to the highest bidder at such sale.

Section 2. The City of Gothenburg further finds that the value of the above described personal property is less than \$5,000.00.


Section 3: An Ordinance confirming this sale shall not be required.
