

RESOLUTION 2009-19

RESOLUTION OF THE MAYOR AND CITY COUNCIL SETTING THE PROPERTY TAX REQUEST FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2009 AND ENDING SEPTEMBER 30, 2010; ESTABLISHING THE PERSONAL AND REAL ESTATE AD VALOREM TAX RATE; AND OTHER MATTERS.

WHEREAS, Section 77-1601.02 RRS provides that the property tax request for the prior year shall be the property tax request for the current year for purposes of the levy set by the County Board of Equalization unless the Governing Body of the City of Gothenburg passes by a majority vote a resolution or ordinance setting the tax request at a different amount; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request; and

WHEREAS, it is in the best interest of the City of Gothenburg that the property tax request for the current year be a different amount than the property tax request for the prior year:


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, NEBRASKA AS FOLLOWS:

- 1.) The property tax request for the fiscal year beginning October 1, 2009 is set at \$444,246.00.
- 2.) The ad valorem tax rate for personal property and real estate for the City of Gothenburg, Dawson County, Nebraska, for the fiscal year beginning October 1, 2009 and ending on September 30, 2010 is hereby set at the rate of 0.309224 for each 100 dollars of actual valuation.
- 3.) The clerk is directed to certify and forward a copy of this resolution to the County Clerk prior to October 13, 2009.




