\*If relocation of city services is required, mover shall provide a \$1000 deposit which will be refunded if there is no damage and after all costs are paid. Mover shall be responsible for all labor, materials and equipment needed for any required temporary relocation of city utilities. Mover shall be liable for any and all damage regardless of deposit except for any negligent damage caused by City Employees.

\*Square footage calculations for the purposes of determining cost of permit shall be: (1) Measured to the outside face of the exterior wall; (2) Must include all potentially habitable space on any level; (3) In renovations and one-level additions to existing structures all areas that are impacted by the work; and (4) Residential garages, up to a maximum of three stalls are not included.

\*\*Building permits requiring stamped plans are determined by the Nebraska State Engineering and Architecture Act

\*\*\*\* Pool parties shall be a minimum of \$50.00; plus \$1.50 per person over 20 persons. Parties shall be scheduled with the Manager or Assistant Manager and shall be subject to available labor and time.
