

**RESOLUTION 2017- 10**  
**ANNUAL APPROPRIATION BILL**

RESOLUTION OF THE MAYOR AND CITY COUNCIL SETTING THE PROPERTY TAX REQUEST FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2017 AND ENDING SEPTEMBER 30, 2018; ESTABLISHING THE PERSONAL AND REAL ESTATE AD VALOREM TAX RATE; ADOPTING A BUDGET STATEMENT AND APPROPRIATING FUNDS TO DEFRAY EXPENSES OF THE CITY.

Whereas, Neb. Rev. Stat. § 77-1601.02 (2009) provides that the property tax request for the prior year shall be the property tax request for the current year for purposes of the levy set by the County Board of Equalization unless the Governing Body of the City of Gothenburg passes by a majority vote a resolution or ordinance setting the tax request at a different amount; and

Whereas, a special public hearing was held, with advance public notice as required by law, to hear and consider comments concerning the property tax request; and

Whereas, it is in the best interest of the City of Gothenburg that the property tax request for the current year be a different amount than the property tax request for the prior year; and

Whereas, Neb. Rev. Stat. § 17-706 (2012) requires that the City Council adopt a budget statement and appropriate the sums set forth therein as necessary to defray the expenses of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, NEBRASKA, AS FOLLOWS:

1. The property tax request for the fiscal year beginning October 1, 2017, be set at \$ 703,555<sup>90</sup>.
  
2. The ad valorem tax rate for personal property and real estate for the City of Gothenburg, Dawson County, Nebraska, for the fiscal year beginning October 1, 2017 and ending on September 30, 2018, is hereby set at a rate of .329455 per each of 100 dollars of actual valuation.
  
3. The budget statement attached hereto as Exhibit A is hereby adopted and the funds described therein are hereby appropriated to defray the expenses and liabilities of the City pursuant to law.

4. The Clerk is directed to certify and forward a copy of this resolution to the County Clerk prior to October 13, 2017.
