

RESOLUTION 2019- 12
ANNUAL APPROPRIATION BILL

RESOLUTION OF THE MAYOR AND CITY COUNCIL SETTING THE PROPERTY TAX REQUEST FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2019, AND ENDING SEPTEMBER 30, 2019; ESTABLISHING THE PERSONAL AND REAL ESTATE AD VALOREM TAX RATE; ADOPTING A BUDGET STATEMENT AND APPROPRIATING FUNDS TO DEFRAY EXPENSES OF THE CITY.

Whereas, Neb. Rev. Stat. § 77-1601.02, as amended, requires that the Governing Body of the City of Gothenburg pass a resolution or ordinance to set the amount of its property tax request after holding a special public hearing; and

Whereas, the Governing Body of the City of Gothenburg seeks to set its property tax request at an amount that exceeds its property tax request in the prior year; and

Whereas, a special public hearing was held, with advance public notice as required by law, to hear and consider comments concerning the property tax request; and

Whereas, Neb. Rev. Stat. § 17-706 (2012) requires that the City Council adopt a budget statement and appropriate the sums set forth therein as necessary to defray the expenses of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, NEBRASKA, AS FOLLOWS:

1. The property tax request for the fiscal year beginning October 1, 2019, be set at \$713,656.
2. The total assessed value of the property differs from last year's total assessed value by 6 percent.
3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$.301725 per \$100 of assessed value.
4. The City of Gothenburg proposes to adopt a property tax request that will cause its tax rate to be \$.301725 per \$100 of assessed value.
5. Based on the proposed property tax request and changes in other revenue, the total operating budget of the City of Gothenburg will exceed last year's by 6 percent.

6. The record vote of the Governing Body of the City of Gothenburg in passing this Resolution is as follows:

7. The ad valorem tax rate for personal property and real estate for the City of Gothenburg, Dawson County, Nebraska, for the fiscal year beginning October 1, 2019 and ending on September 30, 2019, is hereby set at a rate of .301725 per each of \$100 of actual valuation.

8. The budget statement attached hereto as Exhibit A is hereby adopted and the funds described therein are hereby appropriated to defray the expenses and liabilities of the City pursuant to law.

9. The Clerk is directed to certify and forward a copy of this resolution to the County Clerk on or before October 13, 2019.
