

ORDINANCE 968

AN ORDINANCE AMENDING TITLE III, CHAPTER 30, SECTION 30.066 OF THE GOTHENBURG CODE OF ORDINANCES; PROVIDING FOR A METHOD TO ESTABLISH REGULAR MEETING DATE AND TIMES OF THE CITY COUNCIL MEETINGS; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GOTHENBURG, NEBRASKA AS FOLLOWS:

Section 1. Title III, Chapter 30, is hereby amended by amending Section 30.066 of the Gothenburg Code of Ordinances to read as follows:

§ 30.066 TIME AND PLACE OF REGULAR MEETINGS.

Section 2. A copy of prior Section 30.066 is attached hereto as Exhibit A and incorporated herein by this reference.

(A) The City Council shall hold its regular meetings on the first and third Tuesday of each month or such other date and at a time to be established from time to time by resolution of the Council. If the day fixed for any regular meeting of the Council falls upon a day designated by law as a legal or national holiday, the meeting shall be held the same hour on a following day, as may be determined by the Council.


(B) Regular meetings of the Council shall be held in the Council Chambers, City Hall; provided, that the Council may adjourn any meeting to another place as it may deem necessary, desirable, or convenient for the holding of its session; provided further, that if the meeting is adjourned to some other place, notice of the place the meeting is being held shall be affixed to the door of the Council Chambers.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall become effective after its posting and publication as provided by law.





(A) The City Council shall hold its regular meetings on the first and third Tuesday of each month at 7:00 p.m. If the day fixed for any regular meeting of the Council falls upon a day designated by law as a legal or national holiday, the meeting shall be held the same hour on a following day, as may be determined by the Council.
