ordinance no. 969

AN ORDINANCE OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA, DECLARING THE ANNEXATION OF CERTAIN TERRITORY TO THE CORPORATE LIMITS OF THE CITY AFTER A VOTE TO APPROVE A WRITTEN REQUEST FOR ANNEXATION OF SAID TERRITORY.

WHEREAS, the City of Gothenburg, Dawson County, Nebraska ("City"), is the owner of legal title to, and the Gothenburg Airport Authority ("Authority") is the lawful user and occupier of the real estate described on Exhibit "A", attached hereto and incorporated by this reference ("Territory");

WHEREAS, on October 101, 2018, a Request for Annexation of Territory signed on behalf of the Authority was filed in the office of the Clerk of the City along with a plat or map prepared in accordance with Neb. Rev. Stat. § 18-3301 et seq. (Supp. 2017), a true and correct copy of which is attached hereto, marked Exhibit "B", and incorporated by this reference, requesting that the Territory be annexed to the City; and

WHEREAS, the City Council of the City voted to approve the Request for Annexation.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA:

<u>Section 1</u>. The Territory is contiguous to the corporate limits of the City and is urban or suburban in character;

Section 2. The Territory will receive material benefits and advantages from annexation into the corporate limits of the City. It is desirable and for the public good and the best interests of the City that an Ordinance be passed annexing and extending the corporate limits of the City to include the Territory.

Section 3. The Territory is hereby annexed and included within the corporate limits of the City, and the Territory and the persons thereon shall hereafter be subject to all of the rules, regulations, ordinances, taxes, and all other burdens and benefits of other persons and territory included within the corporate limits of the City.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. This Ordinance shall become effective from and after its passage, approval, and publication according to law.
