ORDINANCE NO. 1003

AN ORDINANCE DECLARING: THAT THE COMMUNITY REDEVELOPMENT AUTHORITY IS A PUBLIC AGENCY FOR PURPOSES OF NEB. REV. STAT. 17-503; CONVEYING REAL ESTATE LOCATED IN THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA, MORE PARTICULARLY DESCRIBED IN THE ATTACHED EXHIBIT "A" TO THE COMMUNITY REDEVELOPMENT AUTHORITY OF THE CITY OF GOTHENBURG, NEBRASKA; FINDING THAT THE TRANSFER OF THE REAL ESTATE IS FOR THE REMOVAL OF SUBSTANDARD AND BLIGHTED CONDITIONS; REPEALING ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, Dawson COUNTY, NEBRASKA, AS FOLLOWS:

- Section 1. The Community Redevelopment Authority of the City of Gothenburg, Nebraska is hereby found to be a "public agency" as defined in section 17-503(6)(b) Neb. Rev. Stat.
- Section 2. The City of Gothenburg is the owner of real estate located in the City of Gothenburg, Dawson County, Nebraska, more particularly described in the attached Exhibit "A". Said real estate is deemed to be surplus and is held with out plan of future use by the City.
- Section 3. Pursuant to Sections 18-2138 and 18-2139 Neb. Rev. Stat., the City of Gothenburg, Nebraska, by this Ordinance intends to convey said real estate to the Community Redevelopment Authority of the City of Gothenburg, Nebraska, for disposition pursuant to Community Development Law.
- Section 4. The Mayor of the City of Gothenburg is directed to execute deed of conveyance in the form attached hereto as Exhibit "B" and deliver the same to the Community Redevelopment Authority of the City of Gothenburg conveying the following described property, to wit"

See the attached Exhibit "A", incorporated by this reference.

- Section 5. The City Council finds that the transfer of the property in this Ordinance is necessary for the rehabilitation of blighted and substandard areas within the City of Gothenburg, and that it is appropriate that the Community Redevelopment Authority obtain title to the real estate conveyed hereby.
 - Section 6. This ordinance repeals all ordinances or parts of ordinances in conflict herewith.
- Section 7. This ordinance shall take effect from and after its passage, approval and publication as required by law.
