DISCUSSION ITEMS:

Gary Steele-Engineer discussed Change Order No. 1 of 2021 Paving & Infrastructure Project 126-A1-038. This change order will increase \$78,734.75 from original bid for some additional work on the 11th Street Sewer.

After no further discussion Buddenberg moved, Kennedy seconded, to approve Change Order No. 1 of 2021 Paving & Infrastructure Project 126-A1-038. Roll call vote: Yea –Kennedy, Buddenberg, Richeson, Janssen. No – none. Motion carried.

Venteicher discussed Gothenburg Early Childhood Learning Coalition Memorandum of Understanding for Impact Center. This Memorandum is for the city to invest money to the impact center project. The memorandum is non-binding will be finalized later but is an understanding if the GECLC or Gothenburg Improvement Company fundraises enough money, then the city will pay a total of \$2,500,000.00 towards the project. The city will invest \$900,000.00 for capital cost, \$600,000.00 LB840 for capital cost, and \$1,000,000 in operational cost which is \$100,000.00 for first ten years.

The council discussed project and commitment. Ken Christensen state concerns with the flooding in area that is planned to be built. Mayor Hudson would like reassurance that the public would have access. Venteicher stated the School and City would be co-owners of property to insure it is accountable to public. Kennedy stated that he would like to see cost bonded with new revenue and not delay infrastructure, park improvements, and other things to fund this project.

After no further discussion Janssen moved, Richeson seconded, to approve Gothenburg Early Childhood Learning Coalition Memorandum of Understanding for Impact Center. Roll call vote: Yea –Kennedy, Buddenberg, Richeson, Janssen. No – none. Motion carried.
