Chief Olson discussed Resolution 2022-4 Location of Stop signs at 23rd & Ave M, 23rd & Ave L, and 22nd & Ave L.



City Administrator Greer discussed Ordinance 1009 Annexation for proposed subdivision Hudson Landing.


